RE: Calimira LLC DBA Rusty Bucket Corner Tavern
Liquor Permit Application (Class D5)

I. INTRODUCTION:

The City of Dublin recently received a Notice to Legislative Authority (“Notice”) from the Ohio Division of Liquor Control concerning Calimira LLC’s (“Calimira”) application for a Class D5 liquor permit. Dublin has received this Notice pursuant to R.C. 4303.26 because Calimira’s operations are located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND:

Calimira is a domestic limited liability company doing business as (“DBA”) the Rusty Bucket Corner Tavern at 6726 Perimeter Loop Road. This is the same Rusty Bucket restaurant that is presently operating at the same address. Calimira presently holds a D1, D2, D3, and D6 liquor permit for the premises, and is now seeking to obtain a new D5 permit from the Ohio Division of Liquor Control. There are currently four (4) D5 permits available in the City of Dublin.

The Division of Liquor Control has no records on file regarding any liquor permit violations committed by Calimira in the past. If Calimira’s present application is approved, Calimira will acquire a new D5 permit for the Dublin Rusty Bucket Restaurant.

III. RECOMMENDATION:

It would appear that it is unnecessary to request a hearing in this matter as Calimira is presently operating the Rusty Bucket Restaurant that already holds D1, D2, D3, and D6 liquor permits for the premises. Regardless of whether Dublin desires a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by October 29, 2012.
