Re: Resolution 63-12 - 2013 North Landscape Maintenance

Background

On Friday, October 12, 2012, bids were opened for the 2013 North Landscape Maintenance. Three (3) bids were received:

	<u>Base Bid</u>
Rocky Fork Company	\$251,828.00
Peabody Landscape Group	\$344,982.00
Brickman	\$237,644.00

The funds for this contract are included in the 2013 Operating budget in the amount of \$237,700. This maintenance contract includes all labor, materials and equipment necessary for the maintenance of various landscaped areas and turf within rights-of-way areas.

Recommendation

Staff recommends adoption of Resolution 63-12, accepting Brickman's base bid of \$237,644.00. Brickman has done work for the City of Dublin and staff has found their work to be most satisfactory.
