for D5I and D6 Liquor Permit

**I. INTRODUCTION:**

The City of Dublin recently received a Notice to Legislative Authority ("Notice") from the Ohio Division of Liquor Control concerning American Multi-Cinema Inc.'s ("AMC") application for a new class D5I and D6 liquor permit. Dublin has received this Notice pursuant to R.C. 4303.26 because AMC's proposed location will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

**II. BACKGROUND:**

AMC is an active Missouri Corporation that is registered in Ohio and is doing business as ("DBA") AMC Theatres Dublin Village 18. The address designated for the permit premises is 6700 Village Parkway, which is located west of Sawmill Road in the Dublin Village Shopping Center. AMC currently operates a cinema at the proposed location and is seeking to obtain a new D5I and D6 liquor permit from the Division of Liquor Control ("Division"). A D5I permit differs from a regular D5 permit in that the D5I may only be issued to a retail food establishment or food service operation that is licensed under R.C. Chapter 3717 whose receipts from beer and liquor sales (excluding wine) do not exceed 25% of its total gross receipts. A D6 permit allows certain alcohol sales on Sundays. At present AMC does not possess a license to sell alcohol at the Dublin Village Theatre.

According to the Division's records, AMC is in good standing and does not have any history of violating liquor permit laws. This appears to be a straightforward application for a new D5I and D6 liquor permit. If approved, AMC will obtain a new D5I and D6 liquor permit for use in connection with the Dublin Village Theatre.

**III. RECOMMENDATION:**

Based on the foregoing, it would appear that it is unnecessary to request a hearing in this matter. This appears to be a straightforward application for a new class D5I and D6 liquor permit. The only irregularity in this case is that AMC is operating a theater at the proposed location for the permits. However, many other theaters in Central Ohio already serve alcohol, such as AMC Lennox and AMC Easton, and this application appears consistent with AMC's previous enhancements. Regardless of whether Dublin desires a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by February 7, 2013.


