
Re: Ordinance 52-13 - Changing the Name of Drake Road to Stansbury Drive in the City of Dublin

Summary

Ordinance 51-13 is a request to rename the remaining portion of Drake Road, from its intersection with Springburn Drive to Stansbury Drive, to coincide with the proposed street name planned for the Stansbury at Muirfield Village subdivision.

Existing Drake Road, south of Springburn Drive, is proposed to become the entrance to the new planned subdivision known as Stansbury at Muirfield Village. The proposed road name within the development is Stansbury Drive. The renaming of Drake Road, pending the approval of the rezoning ordinance for the Stansbury at Muirfield Village PUD, is proposed to eliminate confusion as it is proposed to function as the entry into this new subdivision.

Engineering and Police have reviewed this request and support the change. There are no addresses assigned for property or utilities along the portion of Drake Road to be renamed.

Recommendation

Staff recommends City Council approval of Ordinance 52-13 at the second reading/public hearing on June 24, 2013. Should the rezoning ordinance for Stansbury at Muirfield Village (Ordinance 50-13) be postponed or denied, staff will postpone Ordinance 52-13, the renaming of Drake Road to Stansbury Drive accordingly.
