Re: Interstate Management Company, LLC DBA Crowne Plaza Dublin & Patio -
Application for D5A Liquor Permit

I. INTRODUCTION

The City of Dublin recently received a Notice to Legislative Authority (“Notice”) from the Ohio Division of Liquor Control concerning Interstate Management Company, LLC, doing business as Crowne Plaza Dublin & Patio (“Interstate Management”), application for a D5A liquor permit. Dublin has received this Notice pursuant to R.C. 4303.26 because Interstate Management’s proposed location for the permit premises will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND

Interstate Management is a foreign limited liability company that is actively registered with the Virginia Secretary of State. The address designated for the permit premises is 600 Metro Place North, Dublin, Ohio 43017, which is located west of Frantz Road, off of the 33/161 exit. Interstate Management is seeking to obtain a D5A license, which permits spirituous liquor for on premises consumption only; and beer, wine, and mixed beverages for on premises or off premises in original sealed containers until 2:30 a.m. for hotels or motels with fifty (50) or more rooms for transient guests.

According to the Ohio Division of Liquor Control’s records, Interstate Management does not have any history of violating Ohio liquor permit laws. If approved, this will be Interstate Management’s first liquor permit at this location.

III. RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter. Although Interstate Management currently does not have a liquor permit in Ohio, there is no history of liquor law violations. Regardless whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by December 13, 2013.
