Re: Slice of Dublin, LLC DBA LaRosa's- Application for D5I Liquor Permit

I. INTRODUCTION

The City of Dublin recently received a Notice to Legislative Authority ("Notice") from the Ohio Division of Liquor Control regarding Slice of Dublin, LLC DBA LaRosa's ("LaRosa's"). LaRosa's is applying for a D5I liquor permit for its new location in Dublin. Dublin has received this Notice pursuant to R.C. 4303.26 because LaRosa's proposed location for the permit premises will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND

LaRosa's is a domestic limited liability company that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 7048 Hospital Drive, Dublin, Ohio 43016, which is located just west of Avery-Muirfield Drive. This space was formally occupied by Cici's Pizza. LaRosa's is seeking to obtain a D5I liquor permit, which permits the sale of spirituous liquor for on premises consumption only, as well as beer, wine, and mixed beverages for on premises or off premises in original sealed containers. No alcoholic beverages may be sold after 2:30 a.m. LaRosa's application for the D5I permit is currently pending before the Ohio Division of Liquor Control ("Division").

According to the Division's records, LaRosa's does not have a history of violating Ohio liquor permit laws. If approved, this will be LaRosa's first liquor license in the Columbus area.

RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter. LaRosa's does not have a history of violating Ohio liquor permit law. Regardless of whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by July 7, 2014.
