Re: American Multi Cinema Inc. DBA AMC Theatres Dublin Village 18 - Application
for D5 Liquor Permit

I. INTRODUCTION

On July 7, 2014 the City of Dublin recently received a Notice to Legislative Authority (“Notice”) from the Ohio Division of Liquor Control concerning an application for a D5 liquor permit for American Multi Cinema, Inc. DBA AMC Theatres Dublin Village 18 (“AMC”). Dublin has received this Notice pursuant to R.C. 4303.26 because AMC’s proposed location for the permit premises will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND

AMC is a foreign limited liability company that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 6700 Village Parkway, Dublin, Ohio 43017. AMC is seeking to obtain a D5 liquor permit, which permits liquor consumption for on premises only; and beer, wine, and mixed beverages for on or off premises in original sealed containers, until 2:30 a.m. This application is currently pending before the Ohio Division of Liquor Control. It appears that AMC also submitted an application for a D6 permit; however, there is currently no opening for such a permit.

According to the Ohio Division of Liquor Control’s records, AMC does not have any history of violating Ohio liquor permit laws. If approved, this will be AMC’s first liquor permit at this location.

III. RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter. AMC has several liquor permits throughout Ohio with no history of liquor law violations. Regardless of whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control. Originally, a response was to be postmarked no later than August 4, 2014. However, since City Council did not have a regular meeting scheduled until August 11, 2014, a 30-day extension to respond was requested. Accordingly, the Notice must be signed and returned to the Ohio Division of Liquor Control by September 3, 2014.
