Re: Donatos Pizzeria, LLC – Transfer Application for D1 Liquor Permit

I. INTRODUCTION

The City of Dublin recently received a Notice to Legislative Authority (“Notice”) from the Ohio Division of Liquor Control regarding Donatos Pizzeria, LLC, DBA Donatos Pizza (“Donatos”). Donatos submitted an application to transfer a class D1 liquor permit. Dublin has received this Notice pursuant to R.C. 4303.26 because Donatos’ proposed location for the permit premises will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND

Donatos is a foreign limited liability company that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 6 South High Street, Dublin, Ohio 43017, which is located at the corner of South High Street and East Bridge Street (SR 161). Donatos is seeking to transfer a D1 liquor permit from its 6810 Perimeter Loop Drive location. The transfer application is currently pending before the Ohio Division of Liquor Control (“Division”).

According to the Division’s records, Donatos does not have a history of violating Ohio liquor laws. If approved, the Donatos location at 6 South High Street will inherit the D1 liquor permit from its 6810 Perimeter Loop Drive location.

RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter; Donatos does not have a history of violating Ohio liquor laws. Regardless of whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by March 9, 2015.
