Re: McCormack & Taylor LLC DBA Green Olive Company - Application for C2 Liquor Permit

I. INTRODUCTION

The City of Dublin recently received a Notice to Legislative Authority (“Notice”) from the Ohio Division of Liquor Control concerning McCormack & Taylor, LLC, doing business as Green Olive Company (the “Green Olive Company”); the Green Olive Company is applying for a C2 liquor permit for its new location in Dublin. Dublin has received this Notice pursuant to R.C. 4303.26 because the Green Olive Company’s proposed location for the permit premises will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND

The Green Olive Company is a domestic limited liability company that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 36 N. High Street, Dublin, Ohio 43017, which is on the east side of N. High Street, just north of W. Bridge St./SR 161. The Green Olive Company is seeking to obtain a C2 liquor permit, which permits the sale of wine and mixed beverages in sealed containers for carry out only. This permit is specific to retail carryout stores. The Green Olive Company’s application is currently pending before the Ohio Division of Liquor Control (the “Division”).

According to the Division’s records, the Green Olive Company does not have any history of violating Ohio liquor permit laws. If approved, this will be the first liquor permit for the Green Olive Company at this location; it also has a pending application for a D8 liquor permit at this location, which permits the sale of tasting samples of beer, wine, and mixed beverages. Dublin has not yet received notice for this permit application.

III. RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter. The Green Olive Company has no history of liquor law violations. Regardless whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by March 16, 2015.
