

# BRIDGE PARK EAST SECTION 1

## FINAL PLAT

Situated in the State of Ohio, County of Franklin, City of Dublin and in Quarter Township 2, Township 2, Range 19, containing 9.034 acres of land, more or less, said 9.034 acres being a resubdivision of part of Lot 3 as designated and delineated on the subdivision plat entitled "Lands of Chauncy McCloere" of record in Plat Book 12, Page 27 and being comprised of all of that tract of land conveyed to **SCIOTO TULLER ACQUISITION, LLC** by deeds of record in Instrument Number 201308160140286, those tracts of land conveyed to **CITY OF DUBLIN, OHIO** by deeds of record in Instrument Number 201212310201439 and Instrument Number 201408180107456, that tract of land conveyed to **CENTRAL OHIO TRANSIT AUTHORITY** by deed of record in Official Record 202924809 and those tracts of land conveyed to **4351 DALE DR. ACQUISITION, LLC** by deed of record in Instrument Number 20140202013065, all references being to those of record in the Recorder's Office, Franklin County, Ohio.

The undersigned, **SCIOTO TULLER ACQUISITION, LLC** an Ohio limited liability company, by **BRENT CRAWFORD**, Authorized Member, **CITY OF DUBLIN, OHIO** by **DANA McDANIELS**, City Manager, **CENTRAL OHIO TRANSIT AUTHORITY** by **W. SCOTT STITT**, President/CEO and **4351 DALE DR. ACQUISITION, LLC**, by **BRENT D. CRAWFORD**, managing member, owners of the lands platted herein, duly authorized in the premises, does hereby certify that this plat correctly represents their "BRIDGE PARK EAST SECTION 1", a subdivision containing Lots numbered 1 to 3, both inclusive, does hereby accept this plat of same and dedicates to public use, as such, all of the Avenue, Drive and Streets shown hereon and not heretofore dedicated.

The undersigned further agrees that any use or improvements on this land shall be in conformity with all existing valid zoning, platting, health or other lawful rules and regulations, including applicable off-street parking and loading requirements of the City of Dublin, Ohio, for the benefit of itself and all other subsequent owners or assigns taking title from, under or through the undersigned.

Easements are hereby reserved in, over and under areas designated on this plat as "Easement", "Drainage Easement" or "Sidewalk Easement". Each of the aforementioned designated easements permit the construction, operation, and maintenance of all public and quasi public utilities above, beneath, and on the surface of the ground and, where necessary, are for the construction, operation, and maintenance of service connections to all adjacent lots and lands and for storm water drainage. Within those areas designated "Drainage Easement" on this plat, an additional easement is hereby reserved for the purpose of constructing, operating and maintaining major storm water drainage swales and/or other above ground storm water drainage facilities. No above grade structures, dams or other obstructions to the flow of storm water runoff are permitted within Drainage Easement areas as delineated on this plat unless approved by the Dublin City Engineer. Within those areas designated "Sidewalk Easement" on this plat, an additional easement is hereby reserved for the construction and maintenance of a sidewalk for use by the public.



**SURVEY DATA:**

**BASIS OF BEARINGS:** The Bearings shown hereon are based on the Ohio State Plane Coordinate System South Zone as per NAD83 (1986 Adjustment). Control for bearings was from coordinates of monuments FRANK 73 and FRANK 174, established by the Franklin County Engineering Department, using Global Positioning System procedures and equipment, giving a bearing of South 03° 26' 58" West for a portion of Tuller Ridge Drive.

**SOURCE OF DATA:** The sources of recorded survey data referenced in the plan and text of this plat, are the records of the Franklin County, Ohio, Recorder.

**IRON PINS:** Iron pins, where indicated hereon, unless otherwise noted, are to be set and are iron pipes, thirteen sixteenths inch inside diameter, thirty inches long with a plastic plug placed in the top end bearing the initials EMHT INC.

**PERMANENT MARKERS:** Permanent markers, where indicated hereon, are to be one-inch diameter, thirty-inch long, solid iron pins. Pins are to be set to monument the points indicated, and set with the top end flush with the surface of the ground and then capped with an aluminum cap stamped "EMHT INC." Once installed, the top of the cap shall be marked (punched) to record the actual location of the point.
