


**REPLAT OF THE REAR NO BUILD ZONE SETBACK LINE FOR LOT 14

**RECORDING STATEMENT**

This plat entitled "Replat of the Rear No Build Zone Setback Line for Lot 14 Wexford Estates Section 1" is recorded to adjust the rear No Build Zone setback line on Lot 14 of the subdivision plat entitled "Wexford Estates Section 1", of record in Plat Book 77, Pages 87 and 88, Recorder's Office, Franklin County, Ohio. The recording of this plat shall render null and void a portion of the rear No Build Zone on said Wexford Estates Section 1. These revisions have been reviewed and approved by the City of Dublin, Ohio and the owner of said Lot 14. Existing easements within said Lot 14 remain as previously platted. Notes from the original plat in Plat book 77, Pages 87 and 88 remain operative.

Situated in the State of Ohio, County of Franklin, City of Dublin, and in Virginia Military Survey Number 2014, containing 0.114 acre of land, said 0.114 acre being all of Lot 14 of the subdivision entitled "Wexford Estates Section 1", of record in Plat Book 77, Pages 87 and 88, said Lot 14 being conveyed to WILLIAM R. REMIAS, JR. AND ANNE A. REMIAS by deed of record in Instrument Number 20101026014484, Recorder's Office, Franklin County, Ohio.

The undersigned, WILLIAM R. REMIAS, JR. AND ANNE A. REMIAS, owners of the lands platted herein, duly authorized in the premises, do hereby certify that this plat correctly represents said "REPLAT OF THE REAR NO BUILD ZONE SETBACK LINE FOR LOT 14 WEXFORD ESTATES SECTION 1", do hereby accept this plat of same.
