Re: Ephesus Restaurant, LLC - Application for D1 Liquor Permit

I. INTRODUCTION

The City of Dublin recently received a Notice to Legislative Authority (“Notice”) from the Ohio Division of Liquor Control concerning Ephesus Restaurant, LLC’s (“Ephesus”) application for a D1 liquor permit. Dublin has received this Notice pursuant to R.C. 4303.26 because Ephesus’s proposed location for the permit premises will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND

Ephesus is a domestic limited liability company that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 6720 Perimeter Loop Road, Dublin, Ohio 43017, which is just east of Avery-Muirfield Drive. Ephesus is seeking to obtain a D1 license, which permits beer only for on premises consumption or in original sealed containers for carry out only until 1:00 a.m. Ephesus application is currently pending before the Ohio Division of Liquor Control (the “Division”).

According to the Division’s records, Ephesus does not have a history of violating Ohio liquor permit laws. If approved, this will be Ephesus’s first liquor permit at this location.

III. RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter. Ephesus does not have a history of liquor law violations. Regardless whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by November 16, 2015.
