Goal #1: Enhance our readiness and demonstrate our ability to effectively respond to and successfully resolve critical incidents, major crimes, and/or issues of significant community concern.

- >100% increase in violent crimes YTD from 2015








Auto Accidents










City of Dublin - Division of Police - Organizational Chart - Standard 11.1.2



ACCIDENT ANALYSIS January - March 2016

January 1, 2016 through March 31, 2016 there were 209 reported traffic accidents, resulting in an average 2.32 accidents/day. Compared to 2015, accidents decreased 0.95% (2016 = 209; 2015 = 211).

Personal injury accidents (52) accounted for 24.9% of the total. Property damage accidents accounted for the majority of our activity with 157 reports being filed (75.1%).


District 5 experienced the majority of accidents (70 or 33.5%) followed by District 2 with 59 accidents (28.2%). There were 30 collisions each in District 1 (14.4%), 11 collision in District 3 (5.3%) and 39 collisions in District 4 (18.7%). The busiest day of the week for accident activity for the reporting period was Friday with 43 accidents (20.6%) reported. The second busiest day was Thursday with 39 accidents (18.7%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 15 (7.2%); Monday = 25 (12.0%); Tuesday = 32 (15.3%); Wednesday = 33 (15.8%); and Saturday = 22 (10.5%).

The most frequent contributing factor was Following Too Closely, which accounted for 72 or 34.4% of the accidents. The next most recurrent contributing factor was Failure To Control accounting for 41 or 19.6% of the accidents for the reporting period. The busiest time of day for accident activity was between 8AM-9AM with 27 (12.9%) accidents.


Seven (7) crashes were identified as having been alcohol related (3.3%). The drivers in these accidents were arrested and charged with OVI. One hundred sixty-six (166) citations were issued to at fault drivers as a result of their accidents (79.4%).
