Location Transfer Application for D1 and D2 Liquor Permits

### **I. INTRODUCTION**

The City of Dublin recently received a Notice to Legislative Authority (“Notice”) from the Ohio Division of Liquor Control concerning T&K Group Inc.’s (“T&K”) location transfer application for class D1 and D2 liquor permits; T&K is doing business as Sushi Com Japanese Restaurant. Dublin has received this Notice pursuant to R.C. 4303.26 because T&K’s proposed location for the permit premises will be located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permits.

### **II. BACKGROUND**

T&K is a domestic for-profit corporation that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 7178 Muirfield Drive, Dublin, Ohio 43017, which is located right next door to its previous location – 7160 Muirfield Drive. T&K is seeking to transfer its D1 and D2 liquor permits from its previous location. Collectively, D1 and D2 liquor permits allow for the sale of beer, wine, and mixed beverages for on premises consumption or in original sealed containers for carry out until 1:00am. The transfer application for both permits is currently pending before the Division.

According to the Division’s records, T&K is in good standing and does not have any history of violating Ohio liquor permit laws. If approved, T&K will inherit the same D1 and D2 liquor permits that it currently holds at its 7160 Muirfield Drive location.

### **III. RECOMMENDATION**

It would appear that it is unnecessary to request a hearing in this matter. The permits will simply transfer from one location to another, and will be operated by the same owner. Regardless of whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by September 30, 2016.

**4303.13 D-1 permit.**

Permit D-1 may be issued to the owner or operator of a hotel, of a retail food establishment or a food service operation licensed pursuant to Chapter 3717. of the Revised Code that operates as a restaurant for purposes of this chapter, or of a club, amusement park, drugstore, lunch stand, boat, or vessel, to sell beer at retail either in glass or container, for consumption on the premises where sold; and to sell beer at retail in other receptacles or in original containers having a capacity of not more than five and one-sixth gallons not for consumption on the premises where sold. The fee for this permit is three hundred seventy-six dollars for each location, boat, or vessel.

### **4303.14 D-2 permit.**

Permit D-2 may be issued to the owner or operator of a hotel, of a retail food establishment or a food service operation licensed pursuant to Chapter 3717. of the Revised Code that operates as a restaurant for purposes of this chapter, or of a club, boat, or vessel, to sell wine and prepared and bottled cocktails, cordials, and other mixed beverages manufactured and distributed by holders of A-4 and B-4 permits at retail, either in glass or container, for consumption on the premises where sold. The holder of this permit may also sell wine and prepared and bottled cocktails, cordials, and other mixed beverages in original packages and not for consumption on the premises where sold or for resale. The fee for this permit is five hundred sixty-four dollars for each location, boat, or vessel.
