Re: George T IV Inc. DBA Aladdin's Eatery Application for New D5 Liquor Permit

I. INTRODUCTION

The City of Dublin recently received a Notice to Legislative Authority ("Notice") from the Ohio Division of Liquor Control concerning George T IV Inc. DBA Aladdin's Eatery ("Aladdin's"). Dublin received this Notice pursuant to R.C. 4303.26 because Aladdin's applied for a new D5 permit and the proposed location for the permit premises is within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND

George T IV Inc. DBA Aladdin's Eatery is not currently registered with the Ohio Secretary of State. This office contacted the Ohio Secretary of State, Business Services Division, to confirm this fact. This office also contacted the Department of Commerce, Division of Liquor Control (the "Division") to confirm the business status. The Division advised that George T IV Inc. did not submit proof of registration with its application for a new D5 liquor permit, and therefore, the Division will not consider the application unless and until such proof of registration is provided.

The address designated for the permit premises is 6804 Perimeter Loop Road, Dublin, Ohio 43017, which is located in Perimeter Center off of Avery-Muirfield Drive. This location is currently operated as "Pizzafire." Aladdin's is seeking a D5 liquor permit, which permits spirituous liquor for on premises consumption only, and beer, wine, and mixed beverages for on premises or off premises consumption in original sealed containers, until 2:30am. The application is currently pending before the Division.

According to the Division's records, Aladdin's does not have a recent history of Ohio liquor permit law violations issued by the Department of Public Safety.

III. RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter. Aladdin's does not have a recent history of liquor law violations and the Division of Liquor Control will not consider the application unless and until proof of active registration with the Ohio Secretary of State is provided. Regardless whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by November 14, 2016.

[ORC 4303.18](#) Spirituous liquor for on premises consumption only, beer, wine and mixed beverages for on premises, or off premises in original sealed containers, until 2:30am.

4303.18 D-5 permit.

Permit D-5 may be issued to the owner or operator of a retail food establishment or a food service operation licensed pursuant to Chapter 3717. of the Revised Code that operates as a restaurant or night club for purposes of this chapter, to sell beer and any intoxicating liquor at retail, only by the individual drink in glass and from the container, for consumption on the premises where sold, and to sell the same products in the same manner and amounts not for consumption on the premises as may be sold by holders of D-1 and D-2 permits. A person who is the holder of both a D-3 and D-3a permit need not obtain a D-5 permit. The fee for this permit is two thousand three hundred forty-four dollars.
