The following changes shall be made a part of the contract documents for this project:

**QUESTIONS & ANSWERS**

**Question:** RFQ 3.3, Section C states on page 16/23 to only provide resumes of Key Personnel. The table on page 15/23 lists 4 specific Key Personnel and also includes 'Other'. Are the 'Others' considered Key Personnel and can resumes be provided for them?

**Answer** – Yes, the Offeror may provide resumes for Other Key personnel. At a minimum, the Offeror must provide resumes for the four Key Personnel specifically listed in the table on page 15.

**Question:** RFQ 3.3, Section D states that the Past Project Summaries may not exceed 5 pages total. Is it the intent that this Section D only contains the Past Project Summaries or may additional firm capabilities be included in a narrative which would extend the overall section beyond the 5 pages of project summaries?

**Answer** - Additional firm capabilities and experience may be provided in a narrative so long as the maximum number of pages for Sections B, C, and D does not exceed the 24 page limit.


**Question:** Most General Contractors will not hold all of the prequalification Work Types listed in RFQ Section 2.3.3, for example 26) Structural Steel Painting. Is it acceptable to note in the SOQ that qualified subcontractors who hold the appropriate prequalifications will be utilized for these areas?

**Answer** – This question was answered in Addendum 1.

**Question:** Can the City please provide clarification of the estimated fees requested in Section FEES? Is this simply a preconstruction manhour estimate with associated rates for the listed personnel?

**Answer** - Yes, provide a list of personnel classifications that are anticipated to perform pre-construction services along with the associated hourly rates and estimate of hours for each classification.
