# Department Profile

### **Command Staff**

The command staff for the Dublin Police Department consists of the Chief of Police and three bureau commanders. The agency is organized into three bureaus:

• Support Services Bureau • Operations Bureau • Technical Services Bureau

The Support Services bureau consists of the Detective Section, Community Impact Unit and Community Education Unit. The Operations Bureau consists of the Patrol Section which is broken down into three shifts providing seven day a week/24 hour a day patrol service to the community. The Technical Services Bureau includes our Communications, Training, Accreditation and Records Sections.

The department's law enforcement planner provides analysis and reporting services, as well as functioning as the department's crime analyst. Additionally, this position functions as the city's emergency operations coordinator. He works closely with all other city and township departments to ensure the city is prepared to handle any type of emergency.

The accreditation manager is responsible for administering and supervising the department's accreditation process. This position is also responsible for career development, training records and the agency's temporary holding facility.

### Focus & Results

Goal #1: Enhance our readiness and demonstrate our ability to effectively respond to and successfully resolve critical incidents, major crimes, and/or issues of significant community concern.

- Violent crimes decreased from 2019 by 75.0% YTD
- 20.5% decrease in reported crimes from 2019 YTD











### **Auto Accidents**






### City of Dublin - Police Department - Organizational Chart - Standard 11.1.1

### **Annual Review of Complaints, Grievances and Response to Resistance**

The internal affairs function will record, register, and control the investigation of complaints against personnel; will supervise and control the investigation of alleged or suspected misconduct within the agency; and will maintain the confidentiality of the internal affairs investigation and records. Types of Complaints include: Internal Affairs - the investigation of alleged or suspected misconduct within the Agency; Formal Complaint - a known complainant wishes to pursue a formal complaint; and Informal Complaint - a known complainant refuses to formally pursue an allegation or complaint.

All complaints shall have a disposition of one of the following: Improper Conduct - the allegation is true and the actions of the department or the member or employee were inconsistent with policy and the complainant suffered harm; Insufficient Evidence - there is insufficient evidence to confirm or refute the allegation; Policy Failure-Officer Exonerated - the allegation is true and although the actions of the member or employee were not inconsistent with policy, the complainant suffered harm. The officer acted in good faith and within existing department guidelines, rules and regulations; Proper Conduct-Officer Exonerated - the allegation is true, but the action of the department or the member or employee was consistent with policy and the complainant suffered no harm; Unfounded Complaint-Officer Exonerated - the allegation is demonstrably false; Unfounded-No Further Investigation Possible - no investigation was conducted due to lack of information, contractual obligations or other events.

### **Internal Affairs Investigations**

In 2020, there were zero (0) internal affairs investigations conducted by our agency. Compared to 2019, there were three (3) internal affairs investigations conducted by our agency.

### Analysis and Conclusions:

No comparison to identify a pattern of employee or misconduct to the previous year can be conducted due to the fact there were no investigations in 2020.

# Internal Affairs Investigations by Employee Status:

#### Complaints

In 2020, there were two (2) formal complaints and eight (8) informal complaints filed against personnel of the police department. The circumstances surrounding the formal complaints were as follows: 1) Demeanor; 2) Mental Health Transport. Thorough investigations were conducted resulting in the following findings: 1) Improper Conduct – Oral Reprimand Issued; 2) Proper Conduct-Officer Exonerated.

The circumstances surrounding the informal complaints were as follows: 1) Injury During Detention-Sworn; 2) Traffic Stop/Racial Bias-Sworn; 3) Demeanor/Racial Bias-Sworn; 4) Improper Conduct-Civilian; 5) Violation of Social Media Policy-Civilian; 6) Missing Property-Sworn; 7) Demeanor-Sworn; and 8) Cruiser Operation/Demeanor-Sworn.

Thorough investigations were conducted into each complaint. The results of the informal complaints were as follows: 1) Proper Conduct–Officer Exonerated; 2) Unfounded Complaint–Officer Exonerated; 3) Unfounded Complaint–Employee Exonerated; 5) Unfounded Complaint-Employee Exonerated; 5) Unfounded Complaint-Employee Exonerated; 6) Insufficient Evidence-Oral Reprimand; 7) Improper Conduct-Oral Reprimand; and 8) Improper Conduct/Insufficient Evidence-Letter of Counseling for Cruiser Operation.

### Analysis and Conclusions:

A review of complaints both formal and informal for 2020 identified one employee named in three complaints (one formal and two informal); there

Status:

was no other identifiable pattern of employee. The formal complaint was for demeanor resulting in a finding of improper conduct with the employee receiving an oral reprimand. The two informal complaints resulted in one finding of proper conduct and one finding of unfounded; officer exonerated in both instances. Compared to 2019, there was one (1) formal complaint and six (6) informal complaint filed against personnel of the police department. There was one employee named in one (1) informal complaint in 2019 who was also named in 2020. The nature of complaint was not similar to that of 2020. In this instance, the complaint resulted in a finding of improper

conduct and the officer was issued a written reprimand. There was no other identifiable pattern of employee named who received complaints in both 2020 and 2019. A review of the nature of the 2020 complaints when compared to 2019 indicated demeanor as a commonality with three (3) in 2020 and two (2) in 2019. In those instances, only two (2) complaints, both in 2020, resulted in a finding of improper conduct with the personnel involved receiving disciplinary action in the form of oral reprimand.

#### **Grievances**

A grievance is an allegation that there has been a breach, misinterpretation, or improper application of an Agreement. In 2020, there were four (4) grievances filed by employees. Three (3) grievances were related to pay/time issues and one (1) related to a selection process for a rotational position. All grievances, at the time of this report, have been resolved with the following dispositions: 1) denied; no violation of relevant contract language; 2) resolved at Step 1 with proposed remedy; 3) resolved at Step 2, proposed grievance is moot as there is no available remedy; and 4) did not proceed to Step 3 per request of the grievant. In 2019 there were zero (0) grievances filed by employees.

### Analysis and Conclusions:

Due to the fact there were no grievances filed in 2019, an analysis for pattern of employee or grievance type could not be conducted.

### **Response to Resistance**

Any time an officer uses force in an effort to gain compliance from a subject, that response to resistance and subject control shall be documented on the Response to Resistance and Subject Control Report.

- Bodily force shall be documented on a Response to Resistance and Subject Control Report. Minor hand to
  hand control techniques, such as those used in handcuffing, physically touching, or gripping to overcome
  minor resistive tension shall be reported on an incident report or narrative of the arrest form and are not
  considered a response to resistance and subject control. Any bodily force resulting in an alleged injury must
  be reported on a Response to Resistance and Subject Control Report.
- Response to Resistance and Subject Control Reports are also used to document the use of lethal and/or less lethal weapon (in the course of a response to resistance and subject control). This includes: firearm, specialty impact munitions, straight baton, chemical agent (Oleoresin Capsicum), and conducted energy devices (Taser).

In 2020, fifteen (15) response to resistance and subject control incidents occurred that resulted in twenty-nine (29) response to resistance and subject control reports being filed. It should be noted that more reports were filed than total number of incidents due to more than one officer responding to resistance and subject out of a single incident in some, but not all cases.

In 2020, the most common reasons for the response to resistance and subject control were: 1) Necessary to Effect an Arrest, 2) Other Mission-Specific Seizure, and 3) Necessary to Defend Officer/Person. Over the past three years, "Necessary to Effect Arrest" was the most common reason for response to resistance and subject control. In some cases, the numbers may not match up due to some reports having more than one description for the reason for response to resistance and subject control or none being marked on the report.

In 2020, the most common officer responses to response to resistance and subject control incidents included: 1) Verbal or Physical Commands (15 Incidents), 2) Officer Presence (14 Incidents), and 3) Takedowns (13 Incidents). Over the past three years when the data is combined, Officer Presence, Verbal or Physical Commands, and Takedowns have been the top three officer's responses to resistance and subject control techniques. In some cases, the numbers may not match up due to some reports having more than one officer response or none being marked on the report. It should be noted that 13 of the 15 response to resistance and subject.

### Impact on Findings on Policies, Practices, Equipment, and Training

In 2020, a number of significant policies were introduced and/or revised as it related to response to resistance and subject control.

- Policy and Procedure 301.01 was renamed to Reasonable Response to Resistance and Subject Control.
  - The Duty to Intervene was further clarified: Duty to Intervene: Any officer present and observing another
    officer using force that is beyond that which is objectively reasonable under the circumstances shall
    intervene to prevent the further use of unreasonable force.
  - The Duty to Report was further clarified: Any officer who observes or has knowledge of another employee using force that exceeds the degree of force permitted by policy or law shall promptly report these observations to a supervisor.
  - Pointing of a Firearm was further clarified: Sworn officers of this agency should only point a firearm at a
    person when it is objectively reasonable. The most significant factor in establishing objective
    reasonableness when pointing a firearm at a person is a reasonable perception of the threat of death or
    serious physical harm to an officer or the public. Officers should consider the totality of the circumstances
    known at the time of the incident to include the following factors: The severity of the call or offense;

Proximity of weapons; and/or Prior knowledge of the suspect's propensity for violence. This change was in accordance with the case law decision from Lamar Wright v. City of Euclid, Ohio (U.S. Sixth Circuit, Court of Appeals, No. 19-3452, Decided and Filed: June 18, 2020).

- Policy and Procedure 301.02 Officer-Involved Critical Incident / In-Custody Death was revised and renamed.
- Policy and Procedure 301.03 Less-Lethal Weapons had some wording clarified.
- Policy and Procedure 301.04 Rendering Aid After a Response to Resistance and/or Subject Control Technique
  was revised to ensure the members of the Dublin Police Department shall provide medical aid as appropriate
  after any incidents where Response to Resistance and Subject Control techniques have been applied.
- Policy and Procedure 301.05 Response to Resistance and Subject Control Reporting and Analysis of Reports was renamed. In addition, the policy was modified.

Defensive tactics training was conducted with all sworn personnel in 2020 (Training Bulletin 2020-03) as part of the police department's annual in-service training cycle. It is recommended that the Dublin Police Department continue its defensive tactics training with sworn personnel on an annual basis as part of the in-service training program. Since thirteen (13) of the fifteen (15) response to resistance and subject control incidents involved the "takedown" technique, it is recommended that the department's defensive tactics instructors evaluate those takedowns to determine if any additional training needs are necessary or should be considered.

### Response to Resistance and Subject Control Conclusion

In reviewing the twenty-nine (29) response to resistance and subject control reports out of the fifteen (15) response to resistance and subject control incidents that occurred in 2020, it was determined that all policies regarding the response to resistance and subject control were followed (consistent with policy and training) with the exception of one incident (20-0641) that was ruled as the response to resistance and subject control was objectively reasonable, but there was a policy failure. All fifteen (15) response to resistance and subject control incidents were correctly reported, investigated, and reviewed by the chain of command.

Response to Resistance and Subject Control training (Training Bulletin 2020-06) was conducted with all sworn personnel in 2020 as part of the police department's annual mandatory training cycle. Based on this analysis, response to resistance and subject control training will continue to be a part of the police department's annual mandatory in-service training for sworn personnel.

The following should be reviewed by the executive command staff, Defensive Tactics Supervisor and instructors to determine if any further training or policy should be developed and/or implemented:

- From the perspective of individual officer response to resistance and subject control techniques, the "takedown" was the most often used technique over the past three years with 36 out of 42 (86%) response to resistance and subject control incidents involving a takedown technique. The next most common technique was assistance from other officers (33 out of 42 incidents or 79%).
- Another factor for consideration was the "distance from subject". This special circumstance occurred in fifteen (15) of the 42 response to resistance and subject control incidents over the past three years.
- In eleven (11) of the fifteen (15) response to resistance and subject control incidents in 2020, the suspect was suspected to be under: alcohol or drugs, mental distress, and/or some other issue.
- Add a more descriptive requirement in the Response to Resistance and Subject Control Report to identify if an
  officer was assaulted.


Overall, based on this analysis of response to resistance and subject control, no other patterns or trends were identified that would require any further training needs (other than the previously suggested bullet points) or policy modifications.



# ACCIDENT ANALYSIS October - December 2020

October 1, 2020 through December 31, 2020 there were 149 reported traffic accidents, resulting in an average 1.62 accidents/day. Compared to 2019, accidents decreased 39.9% (2020 = 149; 2019 = 248).

Personal injury accidents (54) accounted for 36.2% of the total. Property damage accidents accounted for the majority of our activity with 95 reports being filed (63.8%).


District 5 experienced the majority of accidents (39 or 26.2%) followed by District 2 with 34 accidents (22.8%). There were 23 collisions in District 1 (15.4%); 11 collisions in District 3 (7.4%); 27 collisions in District 4 (18.1%); and 15 collisions in District 6 (10.1%). The busiest day of the week for accident activity for the reporting period was Tuesday with 37 accidents (24.8%) reported. The second busiest day was Friday with with 29 accidents (19.5%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 7 (4.7%); Monday = 23 (15.4%); Wednesday = 20 (13.4%); Thursday = 17 (11.4%); and Saturday = 16 (10.7%).

The most frequent contributing factor was Following Too Closely, which accounted for 31 or 20.8% of the accidents. The next most recurrent contributing factor was tied between Failure To Yield accounting for 28 or 18.9% of the accidents for the reporting period. The busiest time of day for accident activity was between 5PM-6PM with 30 (12.1%) of the accidents.





# ACCIDENT ANALYSIS January - December 2020

January 1, 2020 through December 31, 2020 there were 581 reported traffic accidents, resulting in an average 1.59 accidents/day. Compared to 2019, accidents decreased 35.2% (2020 = 581; 2019 = 896).

Personal injury accidents (174) accounted for 29.9% of the total. Property damage accidents accounted for the majority of our activity with 617 reports being filed (70.1%).


District 2 experienced the majority of accidents (170 or 29.3%) followed by District 5 with 168 accidents (28.9%). There were 76 collisions in District 1 (13.1%), 42 collisions in District 3 (7.2%), 98 collisions in District 4 (16.9%), and 27 collisions in District 6 (4.6%). The busiest day of the week for accident activity for the reporting period was Tuesday with 168 accidents (18.8%) reported. The next busiest day was Friday with 114 accidents (12.7%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 45 (5.0%); Monday = 78 (8.7%); Tuesday = 105 (11.7%); Wednesday = 91 (10.2%); Thursday = 81 (9.0%); and Saturday = 67 (7.5%).

The most frequent contributing factor was Following Too Closely, which accounted for 131 or 22.5% of the accidents. The next most recurrent contributing factor was Failure To Yield (94 or 16.2%). The busiest time of day for accident activity was between 5PM-6PM with 47 (8.1%) accidents.


