E-filing is **faster**, **easier and more accurate than filing a paper return**. E-file makes compliance with reporting and disclosure requirements easier by eliminating the need to make copies, assemble all of the appropriate schedules and attachments, and pay for postage.

Dublin residents can file and pay their return electronically on our website; <a href="www.dublintax.com">www.dublintax.com</a>. As stated above, it's easier, faster and reduces errors in filing. From the website click the efile/epay link and then use the "individuals" link (do not choose the Individual Online Tax Payments), you will need to create an online account with your 6-digit account number. The website is easy to navigate and asks all the relevant questions to prepare your return quickly and efficiently. Once you have completed the steps your return will be ready for filing. You will receive a confirmation number that your return was filed you will have the option to print the return for your records (no need to mail anything to us) if necessary. If you have tax due, you can make a payment from the site using your Checking or Savings account with NO FEE. Additionally, Individuals can make tax payments using Visa, MasterCard, Discover, VISA and MasterCard Debit Card (Please note the credit card company charges a convenience fee, of the total amount remitted).
