The City of Dublin is seeking bids from licensed, qualified contractors to provide repairs to the existing leisure pool shell including resurfacing Diamond Brite, tile, caulking and all related finishes at the Dublin Community Pool South, located at 6363 Woerner Temple Road, Dublin, Ohio 43016 and repaint all pool shells including light concrete work at the Dublin Community Pool North, located at 5660 Dublinshire Road, Dublin, Ohio 43017.

Bids shall be received by the City of Dublin via the Bid Express ® service at [www.bidexpress.com](http://www.bidexpress.com) until 10:00 A.M. local time on Friday, February 28, 2025. Bid documents will not be available until Wednesday, February 12, 2025 at 8:00 a.m.

Each bidder is required to furnish with its proposal a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a surety company or corporation licensed in the State of Ohio to provide said surety.
