Agency Quarterly Activity January – March, 2023

Focus & Results

Goal #1: Enhance our readiness and demonstrate our ability to effectively respond to and successfully resolve critical incidents and/or major crimes

- >Total Part I violent crimes increased from 2022 by 40%
- >3.4% increase in reported crimes YTD from 2022
- >Successfully responded to changing crime trends identified in the city

Goal #2: Reduce theft offenses throughout the city

- ≻7.8% decrease in theft offenses from 2022 YTD
- >29.8% decrease in thefts from vehicles from 2021 YTD
- >38.5% decrease in thefts of motor vehicles from 2022 YTD
- ≻40.0% increase in burglaries and B&Es from 2022 YTD

Goal #3: Improve overall traffic safety in the citv

- >0.8% increase in traffic crashes from 2022 YTD
- ≻50.0% decrease in serious injury traffic crashes from 2022 YTD
- ≥100.0% increase in OVI related traffic crashes from 2022 YTD
- ≻514.3% increase in OVI related arrests 2021 YTD

Goal #4: Enhance and demonstrate our ability to effectively address issues of significant community concern

The department continues to target areas that have seen an increase in theft from vehicle activity, complaints related to parking garages in the Historic Dublin and Bridge Park areas, and continue enforcement efforts throughout the city with traffic and/or speeding concerns.





JANUARY 1, 2023 - MARCH 31, 2023




January - March 2023 Other Reported Activity




City of Dublin - Police Department - Organizational Chart - Standard 11.1.1



ACCIDENT ANALYSIS January - March 2023

January 1, 2023 through March 31, 2023 there were 133 reported traffic accidents, resulting in an average 1.48 accidents/day. Compared to 2022, accidents increased 0.8% (2023 = 133; 2022 = 132).

Personal injury accidents (43) accounted for 32.3% of the total. Property damage accidents accounted for the majority of our activity with 90 reports being filed (67.7%).


District 5 experienced the majority of accidents (45 or 33.8%) followed by District 2 with 37 accidents (27.8%). There were 8 collisions in District 1 (6.0%); 8 collisions in District 3 (6.0%); 28 collisions in District 4 (21.1%); and 7 collisions in District 6 (5.3%). The busiest day of the week for accident activity for the reporting period was Tuesday with 30 accidents (22.6%) reported. The second busiest day was Friday with 29 accidents (21.8%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 18 (13.5%); Monday = 12 (9.0%); Wednesday = 19 (14.3%); Thursday = 20 (15.0%); and Saturday = 5 (3.8%).

The most frequent contributing factor was Following Too Closely which accounted for 31 or 23.3% of the accidents. The next most recurrent contributing factor was Failure To Yield accounting for 26 or 19.5% of the accidents for the reporting period. The busiest time of day for accident activity was between 8AM-9AM with 40 (30.1%) accidents.


Six (6) crashes were identified as having been alcohol related (4.5%). One hundred-nine (109) citations were issued to at fault drivers as a result of their accidents 82.0%
