The Board indicated that some improvements had been made, but noted that the rear massing still needs to be reduced. The front façade detail was considered too busy with both rooflines and materials and should be more vernacular in character. The number of materials should be reduced to two, with perhaps an accent of a third. Finally, the windows should be organized in a more historic pattern, with discernable exterior patterns.
