RESULT: The Commission provided non-binding feedback for a potential rezoning to convert an existing 106-unit extended stay hotel to multi-family apartments. The Commission was split on support for a future rezoning of the existing site. Commissioners expressed concern over open space and parking on the existing site. The Commission recommended that future improvements, such as connectivity, open space, parking, and landscaping, should meet the intent of the Dublin Corporate Area Plan and comply with Code.
