Bid shall provide all materials and labor necessary to repair the existing steps and construct the new kayak launch steps at the bottom of the access stairs at Amberleigh Park in Dublin, Ohio. This will require some work to be done within the edge of the Scioto River. Please visit the site to be familiar with the location and working conditions.

Bids shall be received by the City of Dublin via the Bid Express ® service at [www.bidexpress.com](http://www.bidexpress.com) until 10:00 A.M. local time on Thursday, November 7, 2024. Bid documents will not be available until 8:00 A.M. on Thursday, October 24, 2024.

As a bidder, you must register, set up to bid, and review each solicitation you intend to bid electronically on before bidding. **Note:** Navigation of the Bid Express service is FREE unless you select a solicitation for bidding and complete your purchase.

Each bidder is required to furnish with its proposal a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a surety company or corporation licensed in the State of Ohio to provide said surety.
