RESULT:

The Board confirmed the direction of the Code and Historic Design Guidelines update, Phase 2, which includes two major topics: guidance on Background buildings and potential increase of Administrative Approval items. Members agreed that direction regarding Background building additions, new construction, and some architectural details is needed to preserve the overall character of the district and individual neighborhoods. The Board also discussed a potential list of future Administrative Approvals (single signs, residential paving, Background building materials, and others) to shorten approval times for applicants.
