**RESULT:** The Board discussed the Historic District Code and Guidelines updates, Phase II proposal to increase the number of administrative approvals (AA) permitted and to clarify how Background Buildings are treated. The Board had no objection to the proposed increase in AAs from 11 to 19 project types. The Board reviewed the proposed amendments to the Background Building language in the Code and Guidelines, which focuses on the height, setbacks, massing, roof shape, fenestration, eaves, and overhangs for the buildings on Franklin and S. Riverview Streets that are now classified as background. A draft document will be provided for the July 24 meeting for the Board's further consideration. A formal recommendation of approval of the final draft to the Planning and Zoning Commission and City Council is anticipated at the August 28 ARB meeting.
