Finally, I would like to express my gratitude to the exceptional City staff, whose dedication and commitment to service have brought us to this exciting stage of progress. I am grateful to be surrounded by such a talented, professional and passionate team. Their efforts and accomplishments are highlighted in this update.

Moving forward, I look forward to building upon these accomplishments and advancing many exciting initiatives in the coming months. With the support and collaboration of City Council, our staff and the community, I am confident that we will continue to make Dublin an exemplary city to live, work and thrive.

## 2023/2024 Goals

1

#### Become the Most Connected Community in the U.S.

Phase III: Broadband to the Home Project

Status: The City has been negotiating final terms of an agreement with the selected vendor. Negotiations have revealed some considerations involving Dublink that are important to resolve before presenting a final recommendation to the Council. Staff anticipates presenting a view of all of these conditions as a coordinated and comprehensive package to Council in late May/June as we move toward executing the agreement as the next major step of the project.

#### Realize the Metro Center Revitalization Vision

Reposition the Metro Center legacy office park by implementing the vision and goals of the Dublin Corporate Area Plan. Develop a design and implementation framework that creates a distinctive identity, encourages dynamic reinvestment, provides a vibrant mix of uses in a walkable environment, and promotes sustainable design principles. Identify opportunities for public and private partnerships for catalytic projects that transform the Metro Center area consistent with the framework.

**Status:** Staff is drafting an RFP/RFQ to solicit a proposed scope for a design firm to develop the design and implementation framework for the Metro Center/DCAP area. Staff continues to work with the property owners along the Frantz Road frontage to develop a concept to present to Planning and Zoning Commission.

#### Strengthen the Stewardship and Vitality of our Historic District Core

Explore dedicated day-to-day management and establish definitive goals on "what" the Dublin community aim to preserve — environment, structures, era and architecture. Explore dedicated management and support options and structure that would allow "someone" to wake up every day with the focused mission and tools of delivering on the goals of the district.

Status: City Council provided direction at the May 15 Work Session, which will be incorporated into a draft amendment to the Code and Guidelines. This will be publicly noticed and reviewed by ARB at subsequent meetings. Following ARB's review and recommendation, the amendments will be reviewed and recommended by the Planning and Zoning Commission and then forwarded to City Council for determination. The Community Development Committee previously considered several options for management. One of the City's Economic Development Administrators will focus efforts on our downtown and serve as the primary city resource and liaison with the Historic District. The next Economic Development Director will recruit and fill this vacant position.


#### **Develop Dublin's "Destination of Choice" Next-Generation Community Events Vision.**

Develop a local and regional community events program and management roadmap. Leverage Dublin parks and facilities to create a connected, comprehensive, and fiscally sustainable vision that drives vitality, engagement, and entertainment.

**Status:** Over the past year, staff has conducted numerous efforts in advance of this goal. In advancement of Goal #4, staff has evaluated the City's current event tempo, operating and funding model; researched and analyzed operating models used by cities both domestically and internationally; visited cities both domestically and internationally to experience different events and discuss the funding and management models used by other cities with their staffs; and brought forward new events and policies regarding next-generation community events for Council consideration.




#### **Income Tax Collections**




#### **Income Tax Receipts by Month**

## **Economic Development**

### Highlights

#### **Company News**

ReAlpha, a Dublin-based business that uses AI to guide investments in Airbnb properties, raised \$9.1M in a "mini-IPO." An eventual real IPO is still an option for the startup.

The economic development agreement and incentive for React Health was approved by City Council on May 22. React Health is a manufacturer and distributor of respiratory management, sleep therapy and equipment disinfection products.

Vargo, a leading provider of material-handling systems integration, warehouse execution software and equipment solutions for major fulfillment and distribution centers, officially moved into their headquarters on Frantz Road in April. City Council approved their economic development agreement and incentive in September 2021.


AdVon Commerce, a company offering software solutions for e-commerce, moved into 6555 Longshore Street in Bridge Park in April.

Veterinary Emergency Group opened their first Ohio location on Tuller Road in May.



#### **Workforce Development**

A third Dublin Talent Connect hiring event will be held the week of May 22-26, serving Dublin businesses from all industries. This is the first of two hiring events planned for 2023, in partnership with Chatstrike. While the May event targets new graduates and those searching for entry-level positions, roles for various experience levels will also be a part of available job listings.

#### The Beta District

Marketing efforts continue in support of The Beta District's regional economic development efforts. The District held "Mobility in Color," a red-carpet event for CEOs and venture capitalists of color, with 30 attendees. The event on May 16-17 featured a panel discussion and tour of the Transportation Research Center (TRC).

#### **Strategic Planning Efforts**

Economic Development is scheduled for City Council's June 5 work session to present updated strategies from Newmark and TEConomy. TEConomy has integrated key insights from Newmark's Intel playbook into the overall Economic Development Strategy.

Economic Development will be using CoStar, a comprehensive platform for commercial real estate data, to provide data trends for the commercial real estate data points.


#### **Outreach | Networking**


### **Zoning Compliance Inspections YTD**













#### **New Building Permits Issues YTD**

## **Recreation Update**

### Highlights



#### **Memberships**

- DCRC Member Count is 7,751, which exceeds our pre-COVID peak of 2020.
- Outdoor Pool Pass sales total 4,325, which is ahead of last year at this time. Total passes sold in 2022 was 6,357.

#### **Summer Staffing**

The recruitment efforts of Recreation Services, CPI and HR have been successful, and summer staffing is on target. Wyandot Camp will have staffing for 300 camp slots, which is just 60 slots under pre-pandemic capacity. Aquatics staffing is also on target and should support full operations if nothing else changes.

#### **Teen Programming - E-sports**

In an effort to increase the opportunities for tweens/ teens, the DCRC E-sports initiative is in its final preparation and internal testing phases. The esports room is located in the DCRC and is branded as the Respawn Lounge. It will house open play hours, esports team partnerships and tournaments and many programming and classes for all ages. The initiative will begin with tween and teen programming and grow to include youth and adult STEAM programming.



**Culture Playbook** — An employee survey, focus groups, and stakeholder session in February established a high-level draft of the Culture Playbook. A smaller leadership team met in April and May to further refine the Culture Playbook and a City-wide roll-out is expected over the summer and fall months.

**Compensation Study** – Human Resources will work with our compensation consultant to update our non-union compensation pay grades starting this spring with results in fall.

**Annual Memorial Tournament Employee Appreciation Event** - One of the three annual employee appreciation events. Employees can choose to participate in breakfast or lunch activities while enjoying golf, camaraderie and special activities.

Collective Bargaining — Council recently approved new threeyear agreements with the Fraternal Order of Police Lodge #9 and United Steel Workers. Fraternal Order of Police — Ohio Labor Council will begin negotiations in Fall 2023.

Bring Your Child to Work
Day — On April 27, employees' children joined staff to learn what a local government does, including a mock election, designing a park, talking with police officers and touring City buildings.

- Community Gardens located at Darree Fields have officially opened with 25 garden plots for the community to register and maintain their own gardens throughout the season.
- Citizen U Jumpstart, a teen version of Citizen
  U, has started receiving applications from high
  school students for the July 10-14 program.
- McDaniel Citizen U, A total of 22 adults in this
  year's nine-week Citizen University complete
  their experience on Wednesday, May 24. Ranging in age from 22-81, residents have spent time
  with all City work units and have met City Council
  members during their time in the program. This
  brings the total of active Citizen U alumni to 125.
- Nature Education classes are in full swing with Family Fishing Fun, hikes and outreach to local schools with emphasis on tick safety this spring and summer.

- National Volunteer Week (April 16-22) was
  celebrated in the City with a thank-you to staff for
  working so well with volunteers throughout the



### **Update**

#### **Operating Budget Timeline**

- April 26th The House voted the budget out 78-19.
- June 14th or 15th The Senate is expected to vote on the budget.
- Mid-Late June Once the Senate passes their version of the budget, the bill will go to Conference Committee where key House and Senate members will continue negotiations until they reach an agreement that can be taken to the Governor's desk
- June 30th The constitutional deadline for when a balanced budget bill must be on the Governor's desk, ready to sign.
- July 1st The budget goes into effect.
