## 1. Cramer Creek Corporate Park 23-041MPR, Minor Project Review

The proposal is for exterior modifications to an existing office building located at 270 Cramer Creek Ct. The proposal consists of repainting walls, replacing address numbers, and replacing an awning at an existing corporate office park. The project is intended to update a deteriorated legacy office park building façade. The request is for review and approval of a Minor Project Review under the provisions of Zoning Code Section 153.048.

Mr. Hounshell presented an aerial view of the 3.87-acre site that is zoned MUR-4, Mixed Use Regional – Llewellyn Farms Office, and is located southeast of the intersection of Rings Road and Frantz Road.
