Letter from the City Manager

I am pleased to present the latest City Manager Report, providing an overview of the recent developments and initiatives in our wonderful city. As we reflect on a very busy and lively March, I'm mindful of what an honor and a privilege it is to serve this vibrant community.

Once again, Dublin's Greenest, Grandest St. Patrick's Day Parade was a success, drawing participants and spectators from near and far. The parade showcased our rich cultural heritage and our community spirit. I extend my appreciation to all who contributed to the success of this cherished tradition, from organizers and supporters to volunteers and participants.

That event was followed by our annual State of the City address, which featured a community reception, several informative engagement stations and a program that featured a mix of videos and speakers who spoke to our 2023 accomplishments and 2024 initiatives. The theme was "Our Exceptional Community," and Dublin residents presented various topics. I received overwhelmingly positive feedback from residents and stakeholders who enjoyed many aspects of the event, including the variety of speakers, conversational presentations, upbeat and celebratory atmosphere and the Independence Day headliner announcement.

March also marked the launch of the Everything Dublin store, a one-stop online destination for merchandise related to our beloved city. This partnership between the City and Visit Dublin Ohio provides a way for residents, visitors and employees to show their Dublin pride. Whether you're a longtime resident or a visitor, I encourage you to explore EverythingDublin.com for unique shirts, stickers and other swag.

In recognition of our commitment to solar energy and sustainability, Dublin has been honored with the SolSmart Bronze Award. This prestigious accolade underscores our dedication to environmental stewardship and renewable energy initiatives, including City's Council's December 2023 code amendment that relaxed and clarified restrictions on renewable energy equipment. This policy change paves the way for a greener, more sustainable future in Dublin.



We continue to prioritize strategic planning, with the Envision Dublin Community Plan update and Dublin Sustainability Plan both nearing completion. The Metro Center Revitalization project is underway, with the team finalizing three concepts that will be presented to City Council and the public in April. Additionally, demolition of a former hotel on Tuller Road is underway in preparation for the future Emerald Connector vehicular bridge over I-270.

On March 27, I joined council members at the Ohio University Medical Education Building for a reception welcoming the University's new president, Lori Gonzalez. Dr. Gonzalez became Ohio University's 23rd President in July 2023 and expressed her commitment to the Dublin Campus and her appreciation for the community.

I am proud to report that our city remains safe, welcoming and inclusive, reflecting the values that define us. As we move forward, I am committed to embracing innovation, diversity and collaboration, ensuring that Dublin continues to set the standard for community excellence.

1

Become the Most Connected Community in the U.S.

Phase III: Broadband to the Home Project

Status: At the Feb. 26 Council meeting, staff and an altafiber representative presented a project status update that included a construction phase plan map that may be viewed here https://dublinohiousa.gov/most-connected/. altafiber has submitted the first phase one right-of-way permits and Engineering is working through the approval process. Construction will begin in April 2024. In addition to continued collaboration on the resident communication plan, altafiber will be mailing general information postcards and distributing door hangers as construction begins. The website has had 3,280 + project page views (with 650 occurring after the Feb. 26 Council meeting), 1,450+ residents have signed up for updates and a total of 552 residents have notified altafiber of having a dog fence and/ or sprinkler system. This information will help altafiber coordinate how they enter a resident's yard when laying fiber in order to make the least amount of impact on the resident. altafiber and Dublink Development Company LLC have executed a lease agreement that will allow altafiber to utilize the Dublink multi-conduit system.

2

Realize the Metro Center Revitalization Vision

Reposition the Metro Center legacy office park by implementing the vision and goals of the Dublin Corporate Area Plan. Develop a design and implementation framework that creates a distinctive identity, encourages dynamic reinvestment, provides a vibrant mix of uses in a walkable environment, and promotes sustainable design principles. Identify opportunities for public and private partnerships for catalytic projects that transform the Metro Center area consistent with the framework.

Status: The City's consultant team, Sasaki and EMH&T are developing implementation scenarios for Council's consideration based on the feedback gained from the work session with City Council Jan. 29 and the input provided at the public meeting Jan. 30. Staff will provide an update to City Council April 22, followed by a detailed review of scenarios at the May 13 work session.

3

Strengthen the Stewardship and Vitality of our Historic District Core

Explore dedicated day-to-day management and establish definitive goals on what the Dublin community aims to preserve — environment, structures, era and architecture. Explore dedicated management and support options and structure that would allow "someone" to wake up every day with the focused mission and tools of delivering on the goals of the district.

Status: Staff has begun working on phase two amendments to the Code and Guidelines to provide additional stafflevel approval criteria within the Code and clarify how the Code and Guidelines will be applied to background buildings. The amendments will be presented to the Architectural Review Board at a special meeting April 17. The Dublin Community Improvement Corporation approved its second round of applications for the newly reinstated Commercial Façade Improvement Program. A new Economic Development Administrator was recently hired and will focus efforts on our downtown and serve as the primary City resource and liaison.

4

Develop Dublin's "Destination of Choice" Next-Generation Community Events Vision
Develop a local and regional community events program and management roadmap. Leverage Dublin parks and facilities to create a connected, comprehensive and fiscally sustainable vision that drives vitality, engagement and entertainment.

Status: Staff members have evaluated the City's current event tempo, operating and funding model; researched, visited and analyzed event operating, funding and management models in other cities; and brought forward new events and policies regarding next-generation community events for Council's consideration. A selection committee will meet to evaluate five responses received in response to the Holiday Market Feasibility Study RFP in the coming weeks. With regard to the RFP for potential firms to partner to develop an events program and management roadmap, staff members revised and reissued the RFP with responses due March 22. A committee of stakeholders comprised of key City staff, Visit Dublin Ohio and the Downtown Strategic Alliance, and a Council Member will meet in the coming weeks to evaluate the four responses received.

PROJECT	DESCRIPTION	STATUS
Bright Road Corridor Improvements and the Emerald Parkway/Mount Carmel Roundabout	As part of the economic development agreement with Mount Carmel Health System, improvements are planned to ease congestion at two locations in east Dublin, the Bright Road Corridor and the main entrance to the Mount Carmel site along Emerald Parkway. Improvements are being coordinated with the new Mount Carmel Health System hospital in the southwest quadrant of the Sawmill and Bright roads intersection.	The consultant is routing the plans for the City of Columbus' signatures. Utility coordination is ongoing. Right-of-way acquisition and negotiations are underway after acquisition authorization and appropriations were approved at the Nov. 27, 2023, City Council meeting. This project is being coordinated with the design of the roundabout at the Emerald Parkway and Mount Carmel Health Systems main access. PROWAG pedestrian crossing enhancements have been added to the plans. The bid opening took place March 12. Four bids were received. Bid acceptance took place at the March 25 City Council meeting. Completion of the roundabout is planned for fall 2024. The Bright Road Corridor completion will follow in fall 2025.
COhatch Headquarters	At the Sept. 11, 2023, City Council meeting, Council approved a real estate transfer and development agreement for the development of COhatch's corporate headquarters. The headquarters development will be a first of-its-kind coworking and entrepreneurship district in Historic Dublin.	On March 27, the Architectural Review Board (ARB) reviewed and recommended to City Council approval with conditions of the concept plan previously submitted by COhatch. The plan includes renovation and conversion of the three houses on the west side of North Riverview Street into private office suites and the red house on the east side into a restaurant. It also includes the construction of a new 15,000 square foot COhatch building south of the restaurant, along with public spaces throughout the site. The concept plan is expected to be presented to City Council for approval at the April 22 meeting. ARB also approved the demolition of three background outbuildings along North Blacksmith Lane. Regular meetings between COhatch and City Staff and consultants are ongoing to ensure coordination with the planning for the surrounding street improvements and Riverside Crossing Park.
Community Gateway Signs	City Council approved an initial design concept in March 2022 for new community gateway signs at key entrances to the City, following a recommendation from the Community Development Committee. To properly recognize the many accolades and achievements the City of Dublin has earned, City Council requested these be incorporated as an additional sign or modified original design. Staff members are creating a revised community gateway sign design to accommodate the various site conditions and incorporate such accolades.	City Council referred this topic to the Community Development Committee (CDC) at the Nov. 13 meeting. Staff members are currently reviewing concepts provided by the consultant and will bring options to the CDC at the April meeting.

PROJECT

Community Health Needs Assessment

DESCRIPTION

The Community Health Needs Assessment (CHNA) is a systematic process involving the community to identify, analyze and prioritize community health needs as well as plan to act upon unmet community health needs. Guiding this effort is the Advisory Committee, which includes the City, Washington Township, each of the four major health systems, mental health care providers, Dublin City Schools and a variety of social service organizations that serve Dublin residents.

STATUS

The CHNA Advisory Committee met Feb. 9 to review the draft report, and identified four priority health needs. City staff members are working to identify members for the working groups that will address these priority health needs. The working groups will meet several times over the next few months to develop strategies, action steps and timelines to address the priority areas. The report is anticipated to be reviewed by City Council in Q3 2024.

Envision Dublin Community Plan Update

The Envision Dublin Community Plan will be a roadmap for the City to direct future growth and development over the next 20 years. The Envision Dublin process is currently focused on land-use modeling, in conjunction with transportation and mobility and utility service modeling, which has been informed by the work of the Steering Committee. The committee has also focused its efforts on the development and initial recommendations of the Special Area Plans. The modeling efforts and Special Area Plan development will result in a preferred land-use scenario and detailed recommendations for the area plans that will be incorporated into the final Community Plan, which is targeted for completion in June 2024.

The consultant provided an update at the Feb. 26 City Council meeting, giving the public another opportunity to engage with the project. The Steering Committee continues to help guide the Community Plan's updates with the most recent meeting held Feb. 27, which focused on land-use scenarios and an introduction to the mobility plan. The Steering Committee held a meeting on March 26 to review the Preferred Land Use Plan, draft Special Area Plans an analysis and a recommendation related to Transportation & Mobility, Utilities and Fiscal Analysis. The plan can be determined as substantially complete following the Steering Committee's review process. A final public engagement session is scheduled for April 2 to review these same topics, prior to the Steering Committee reviewing the final Envision Dublin Plan document and the start of the formal public adoption process.

EV Infrastructure Comprehensive Plan

Develop a comprehensive plan researching and recommending the types and appropriate placement of electric vehicle (EV) charging infrastructure for both electric vehicles and e-bikes.

Staff members are developing a comprehensive plan for electric vehicle charging infrastructure based on EV adoption rates, industry best practices and data from the City. Staff members anticipate receiving the 90% submission of the report in April and bringing it forward to City Council for review in Q3 2024.

Dublin Community Recreation Center Refresh

In 2022, Council directed \$3.1 million of American Rescue Plan Act funds for improvements to the Dublin Community Recreation Center (DCRC). Subsequently, staff members began working to identify an architect to update the improvement scenarios identified pre-pandemic, a task which was complicated by the high growth of inflation, especially in the construction industry. In July 2022, the City contracted with MSA Design to update the necessary improvements and associated costs for the DCRC. This project also incorporates the Mobility Hub to reduce costs associated with individual construction projects.

The DCRC Refresh continues to progress through phase three. Staff members and MSA Design have distilled and analyzed all the feedback received to produce renderings for review. These renderings were presented for public feedback at the March 12 meeting of the Community Services Advisory Commission, the third public engagement meeting March 13 and were on display in the exhibition area at the State of the City address. The consultant is working to develop cost estimates, schedules and phasing plans. Staff members plan to bring the project to City Council in May.

City of Columbus Fourth Water Plant	The City of Columbus Department of Public Utilities is building a fourth water plant and transmission mains to prepare for the growing need for clean, safe drinking water in Central Ohio.	Dublin and Columbus city staff members are meeting in April to review and discuss the preliminary alignments for the water transmission mains proposed to come through Dublin from the fourth Columbus water treatment plant in Rathbone (intersection of Dublin and Home Roads). Columbus will provide Dublin a presentation on the alignment study process, including alignment evaluation guidelines, comparison analysis, risk analysis and cost estimates leading to the preferred alignment. Columbus evaluated several routes and narrowed it down to three recommended routs. One option primarily uses Muirfield Drive. Another is along Avery Road, and a third would follow Hyland-Croy Road. The final design of the first transmission main is expected to start spring 2024. Construction of that main is anticipated to commence in 2026 and be completed in 2028. The final design of the second transmission main is expected to begin in summer 2024 with construction beginning in 2027 and ending in 2029.
Dublin Sustainability Plan	In connection with the Envision Dublin Community Plan, the Dublin Sustainability Plan will be a guiding document to advance the City's sustainability efforts. Asakura Robinson, an award-winning planning and urban design firm, is providing consultant services for this project. EcoDublin, the City's internal Sustainability Committee, meets biweekly with the consultant.	The updated draft of the Dublin Sustainability Plan is being finalized by City leadership to ensure that the goals and recommendations are forward-thinking, innovative and attainable. To allow time for the consultant to amend the Plan based on feedback from senior leadership, the Plan is now scheduled to be reviewed by City Council at the May 20 meeting.
Holiday Market Feasibility Study	At the recommendation of the Public Services Committee, City Council unanimously voted Oct. 9, 2023, to direct Staff to move forward with the second phase of a feasibility study to analyze a potential holiday market in Dublin.	The RFP for consultant services to conduct a feasibility study for a potential holiday market in Dublin was issued Feb. 20. Multiple consultants requested additional time to provide a response. The deadline for firms to submit a response was amended to March 22. A selection committee will meet to review the five responses received in the coming weeks.
Performing Arts Center Feasibility Study	The City engaged Webb Mgmt to conduct a feasibility study to complete a proposed business plan, potential site locations and pro forma for a potential performing arts center	Webb Mgmt conducted phase one and two City Council. Following a review of the information provided by Webb Mgmt, the CDC recommended to City Council to accept the Performing Arts Center Feasibility Study. Council accepted the report at the Nov. 13, 2023 meeting and determined that additional discussion would take place as part of future work sessions and the retreat. City Council will be discussing the topic of a potential performing arts center, including the economics and timing, at the 2024 Council Retreat.

PROJECT	DESCRIPTION	STATUS
Post Road Interchange	This project provides for U.S. 33/S.R. 161/Post Road interchange ramps and terminal intersections previously approved by the Federal Highway Administration and Ohio Department of Transportation (ODOT). The project will provide the needed interchange capacity improvements.	Construction is underway and managed by ODOT. Reconstruction of both U.S. 33 bridges over Post Road/S.R. 161 and reconstruction/widening of Post Road/S.R. 161 is expected to be complete by June 2025. The westbound ramp of Post Road/S.R. 161 to U.S. 33 eastbound is closed through spring 2024. Traffic will need to use the Eiterman Road roundabout to access the U.S. 33 eastbound ramp. The new alignment of the U.S. 33 eastbound ramp to Post Rd./S.R. 161 eastbound has opened. Traffic will be routed to the Eiterman Road roundabout to access Post Rd./S.R. 161 eastbound. The Hyland-Croy intersection will remain right-in, right-out only until late 2024. The Post Preserve Boulevard intersection has been permanently converted to right-in, right-out.
Riverside Crossing Park Master Plan	Master planning of Riverside Crossing Park is set to include consideration of many elements, including river access; a kayak launch site; connectivity to Dublin Springs and Indian Run Falls parks; adventure elements; walking trails; a Japanese style garden; updates to the great lawn for festivals; revisiting the promenade in conjunction with festivals being held on the great lawn; and other supporting elements.	The consultants and staff members met at the west bank of the river to discuss potential concepts based on the layout and ideas from the Parks and Recreation Master Plan. There will be multiple public engagement sessions and stakeholder meetings throughout 2024. The City is working to schedule public engagement on this project. Some engagement will coincide with the COhatch Headquarters project, while additional public input will be held regarding the park at large. Staff members are targeting completion in Q1 2025.
Curbside Management	This project creates a curbside management plan to define an overall plan for the valuable and flexible public space in areas such as Bridge Park and Historic Dublin. To better manage the important asset, a clear, consistent, and implementable framework for prioritizing goods and people movement is needed. A thoughtful framework will improve urban goods delivery while reducing conflicts between trucks, motor vehicles, bicyclists, pedestrians, and micro-transit. The goal is to reduce friction between competing uses by analyzing existing conditions; exploring best practices; developing a series of policies and implementable recommendations; and designing pilot demonstration(s) to address the most pressing urban curbside management challenges.	Staff members are evaluating the loading zones on Longshore Street in Bridge Park to improve curbside operations and reduce double parking conflicts. Staff members are using data from Automotus, a technology parking company included as a partner in the pilot project phase of the Curbside Management Plan, to analyze parking behaviors and durations to determine appropriate wording for the signs and enforcement. Staff members will be working with Fybr in the next few months to place sensors detecting occupancy, duration and double-park violations. This information will be shared with the Police Department. An update on the Plan is anticipated to go before the Public Services Committee in May, with project completion scheduled for Q3 2024.
The Emerald Connector (Tuller Road/ Emerald Parkway Over 270 Crossing)	This project provides for an evaluation of a new crossing over I-270 from Tuller Road to Emerald Parkway. This work will continue to develop bridge and intersection details, mobility features, utility infrastructure and aesthetic elements. View a complete list of projects.	Staff members are reviewing the 90% submission. Detailed design and consultant selection was completed as part of the Winter Consultant Services Bulletin. The preferred consultant provided a fee proposal Feb. 13, 2024. The bid acceptance for the demolition of the existing structure at 4130 Tuller Road was approved at the Feb. 5, 2024, City Council meeting. Ahead of the demolition, the Dublin Police Department conducted new hire practical training scenarios, and the Delaware Tactical Unit also trained there. The demolition permit was approved by the Administrative Review Team on Feb. 28, with demolition underway.





Business Retention & Expansion

An economic development agreement was approved with Sarnova for the purchase of a building for their corporate headquarters. Sarnova is a specialty medical sales, service and distribution company. The project expects to retain 192 existing employee positions within the City. In addition, the company expects to create 15 new employee positions, for a total of 207 employees within the City by Dec. 31, 2028.

The Economic Development team continues to work through the SiteOhio certification program administered by JobsOhio. A site visit is expected in April or May and is a necessary step before certification by the state of Ohio as shovel-ready for development.

Rev1 Ventures Partnership

Rev1 Ventures staff presented at the March 25, 2024 City Council meeting to provide an update on outcomes of the 2023 high-tech entrepreneurial services contract. Staff is exercising the first one-year term renewal option in the contract with Rev1 Ventures, for 2024. This investment is supported by the 2023 Economic Development Strategic Plan that calls for fostering sustainable partnerships that catalyze value-added collaborations. Innovation

Economic Development continues to update its website with more useful tools for businesses, developers and site selectors. The Economic Development Division utilizes site capacity studies to study undeveloped sites throughout the City. These studies create a site layout plan to showcase development opportunities to spark interest for development. In addition to the new mapping tool on the Economic Development website, Economic Development, Planning and GIS are working together to use 3D imaging to display the site capacity studies on available sites throughout the City.



In March, the Dublin CIC executed an agreement with Avant Communications for Dublink Transport Referrals. Both Dublink Transport data center partners are active partners with Avant and utilize their services as a referral partner. Board Member Jeremiah Gracia, Treasurer Matt Stiffler and Secretary Kendel Blake participated in benchmarking interviews with Staff from local CIC's in the region as part of Montrose Group's strategic planning effort. The results of the benchmarking efforts along with a review of the CIC's bylaws will be presented at the next CIC meeting April 22.

Community Development

Boards & Commission Activity

Renewable Energy Equipment - Solar

The City of Dublin was awarded the SolSmart Bronze designation for its commitment to make it faster, easier and more affordable to go solar. This designation is in recognition of all the hard work and leadership the City has shown to reduce soft costs and encourage solar energy growth at the local level.

Since the Dec. 11, 2023 code amendments, a total of 16 permit applications have been submitted with 14 approved and two not approved. The two that have not been approved do not meet the color requirement or the configuration requirement. The applicants have been provided feedback regarding whether modifications can be made to meet the requirements, but it is challenging to address color requirement without major alterations. Overall, from staff's perspective, the amendment has helped address the concerns raised earlier this year with an approval rate of 88% for these permits submitted since the amendment.

Regional Items of Interest

Logan-Union-Champaign Regional Planning Commission met March 14 and heard five cases. The cases included three plats and two text modifications. The text modifications were for Mad River Township and Salem Township, which are not in close proximity to the City of Dublin. Two of the plats were for the Mitchell Highlands subdivision (Sections 3 and 5), which are in Jerome Township off Industrial Parkway and Dewitt Road. The two plats approved the creation of 51 lots in total.

Delaware County Regional Planning Commission reviewed the Avasar LLC rezoning request from Farm Residential (FR-1) to Planned Commercial Development (PCD) to allow for an agritourism business just north of Dublin Road and SR 42. The request was recommended for conditional approval. Concord Township requested a meeting between all member-elected officials and the Commission to ensure that member goals are being adequately represented in Staff reports and the Commission's votes. The executive committee will arrange this meeting to occur in the next 60 days.

Boards & Commissions Activity

The Planning and Zoning Commission heard two cases in March. The Bailey's Master Sign Plan was approved following updates to the sign package in January. Lightbridge Academy's request was considered informally by the Commission for a new daycare facility in the northwestern lot of The Corners development. The Commission was supportive of the use, stating the use fits the intent of the development. The next step for the application is a Final Development Plan with Text Modifications to permit daycare use of the site. Find a list of the March caseload and upcoming cases here.

The Architectural Review Board heard five cases including the Concept Plan and Demolition requests for Riverview Village. Staff and the Board noted that COhatch is largely preserving the historic houses and keeping the original character of North Riverview Street intact. Demolition requests were for outbuildings along North Blacksmith Lane that are within the existing right-of-way. Staff provided an ArcGIS 3D model of the project along with residential requests to the south. Find a list of the March caseload and upcoming cases here.

The Board of Zoning Appeals heard three Variance requests. Two requests were for fences not meeting location and design requirements. The third request was for a new single-family home being built along Riverside Drive that did not meet building siting and residential appearance standards. The Administrative Review Team heard one case in March. J. Hilburn Stylist Studio was approved for exterior modifications within the Bridge Park development. Find a list of the March caseload and upcoming cases here.

Historic District Office Hours

Since December, Staff has held monthly office hours in the district pursuant to Council Goal 3. In December, we had strong attendance of residents and business owners who were mostly interested in talking about the proposed park master plan for the west side of the river. Since the first meeting, resident participation has declined and staff is reevaluating the need for these office hours. Staff began the meetings in December to determine if such a resource would be utilized by those in the Historic District, as Architectural Review Board has observed an uptick in cases being heard.

Compliance & Enforcement

Code Enforcement

Vehicle storage complaints (RVs/boats/trailers in driveways) are reported year-round but are more commonly reported in spring and fall as the owners transition from storage arrangements. Recreational vehicles and boats can be on site for a limited period before and after use for maintenance and loading/unloading, with prior notification to Code Enforcement. Visitors can park an RV in a driveway for 72 hours but cannot sleep in the vehicle. Other common vehicle complaints involve location. All vehicles must be parked on a hard surface. The one area that Code Enforcement cannot address is vehicles parked on the street, which are referred to the Dublin Police Department non-emergency number: 614.889.1112.

Ongoing Projects

Within the City of Dublin, we have seen an increase in the number of home-based businesses, especially in the last three years. When a concern is received from a neighbor or a homeowners association representative, each is assessed independently based on Code 153.073. While many do not meet the code criteria for a Home Occupation Permit to be necessary, those that do file for a Two-Year Permit that specifies rules to maintain, including no exterior signage and limits on storage of materials/vehicles.

Zoning & Code Compliance

Daily Zoning Inspections

Twenty daily zoning inspections were performed during February. These daily inspections ensure compliance with zoning codes for completed construction projects, including pool installations, solar panels, decks, new homes and commercial additions.

These inspections include commercial alterations at 35 North High Street and 6671 Village Parkway and a new commercial building at 4998 Rings Road.

Routine Landscape Inspections

Fifteen landscape inspections were performed in February. Landscape inspections identify missing, dead or dying plant material as well as other zoning code violations.

No follow-up inspections were scheduled for February.

Building Standards

Certificate of Occupancy

Thirty-four Certificates of Occupancy (C of O) were issued this month. C of Os of interest this month:

Plan Review Turnaround Times

Building Standards is generally consistent at a Commercial 10 + - 100 calendar day turn-around. This month is better than average at 9.38 days. Residential reviews are at a 5.96 calendar day turn-around this month. This is significantly better than our 14 calendar day target.

Speed Management



Operations and management of the speed safety cameras installed last month are in the initial stages as staff members are evaluating and exploring how the cameras function for the optimal benefits for the

community. A blinker speed limit sign was installed the week of March 4 on Riverside Drive to heighten driver awareness entering the Bridge Park area and to encourage speed compliance. Staff members are preparing updated tactical urbanism materials, incorporating feedback from CSAC's December meeting, and plan to bring a recommendation forward to City Council in Q2 2024. The dashboard, which displays fatal and serious injury crashes, monthly speeding citations issued and total monthly traffic stops, can be viewed. View the dashboard.

Electric Scooters

Given winter 2024 is the first-time skeleton winter operations occurred in Dublin, there is no year over year data to compare.

LinkUS

Staff members continue to engage with the region regarding the LinkUS program. City Manager O'Callaghan represents the interests of Dublin and other suburbs on the Executive Council. At its March meeting, the Committee discussed outreach activities around Central Ohio. O'Callaghan shared that LinkUS was featured at Dublin's State of the City event through an engagement station, video and testimonial from a Dublin resident. Ms. Willis attends the Northwest Technical Working Group meetings. The group met in March to begin drafting the 2026-2030 5-year CIP for Transit Supportive Infrastructure. Included are seven projects in Dublin, ranging from preliminary engineering to construction, included for funding in 2026.

Horticulture & Forestry

- Staff members mowed remaining natural areas to prepare them for spring.
- Spring plant material was installed in the planter boxes at City buildings, Riverside Crossing and in Historic Dublin.

- Plans were finalized for Sustainable Saturday, which will be held at the Service Center, 8 a.m. — 1 p.m.
 May 4, providing a one-stop drop-off for household hazardous waste, documents to be shredded, unused pills, Styrofoam packaging materials, e-waste, clothing, linens and other small house items.

Streets

- Provided set-up and event staffing support for the St.
 Patrick's Day parade, including safety measures such as barricades and road closures.
- Trash and litter were removed from I-270 and U.S. 33.
- Staff members replaced Americans with Disabilities Act-compliant curb mats at the Dublin Community Recreation Center, Coventry Woods Drive and Brand Road, and Scioto High School.
- City salt barns were restocked with 1,800 tons of salt.



Parks

- Provided set-up and event staffing support for the St. Patrick's Day parade.
- Staff members removed old wood benches from Downtown Dublin and installed 29 new benches.
- Top rails were repaired or replaced at Indian Run Falls
- Staff members began mowing athletics fields and performing infield maintenance, including infield grading.
- Staff performed annual inspections on park furniture, shelter house picnic tables and park benches. Repairs were performed, as needed.

Wildlife Management



Upon review of the updated code language for Section 91.12 of the City's codified ordinances, it was determined that there was a narrow conflict with Section 91.06 regarding cats as companion

animals. The first reading of the revised code language that removes the conflict from Section 91.12 was heard by City Council at the March 25 meeting. The second reading will take place April 22.

Staff members continue to monitor all reports of potential code violations, excluding any related to feeding of cats, and responding to such reports with educational materials. A dashboard is being used to help view the addresses for requests and determine if multiple requests have been entered that are associated with the same address to inform the appropriate response. 
Asset Management & Quality Assurance

Inspections/Maintenance Work

- Staff members are working on the concrete sidewalk lifting pilot program as an additional tool for the sidewalk maintenance program. The pilot will address approximately 50 locations this summer.
- Staff members are preparing the light pole painting program based on 2023 inspection data.
- In partnership with Engineering, Asset Management & Quality Assurance (AMQA) staff members are updating the pavement striping and marking inventory and will be performing inspections in the coming weeks to assist with the program.
- AMQA is preparing a storm structure maintenance program in partnership with Engineering.
- Staff is preparing the 2024 Pavement Preventive Maintenance Program, as well as a revised 2025-2029 Street Maintenance Program based on recent pavement data.
- Downtown Brick Sidewalk Maintenance Program began March 18 and will address 13 locations in Historic Dublin.

GoDublin

Six hundred and thirty-eight requests were submitted in February, an increase from 538 last month. Of those requests, 400 (63%) were initiated through the GoDublin app. By comparison, there were 674 requests in February 2023.

Dead animal pickup reentered the top five request types this month replacing yard waste collection missed. The top 10 requests generally account for 80% of all requests per month.



Programs and Events

The spring/summer <u>Healthy Programs and Activities</u> <u>Guide</u> was released digitally March 5 and is the largest guide to date totaling 116 pages.

Summer camp registration began March 14 for all eight-week priority registration and continued with weekly registrations March 15. For the first time since the pandemic, the full inventory of camp offerings was available, increasing the enrollment capacity. The increased capacity enabled registration to remain open for hours rather than filling up within minutes, as occurred the past few years.

Adaptive programming partnered with All R Friends to host an adult St. Patrick's Day Dance March 12. Participants enjoyed light refreshments, a DJ and dancing with friends.



Ohio Parks and Recreation Association Awards

The Adaptive Extravaganza received third place in Adaptive Programs & Events at the recent Ohio Parks and Recreation Association awards presentation. The program was formed as an internal partnership between adaptive recreation programming and the theater supervisor, with the intention of having an accessible theater program designed specifically to include individuals of all abilities in every aspect of a theatrical production experience. During this program, individuals with disabilities who seek to perform were invited to sing, dance or perform in any way they chose in a safe space, which welcomes them to express themselves and share their talents with the Dublin community.

Summer Staff Recruitment

Recruitment for summer continues to focus on camp leadership and aquatic service manager positions. Camps are showing a 72% retention rate for the year. Thirtytwo new camp Staff have been hired, which puts camp positions at 75% filled for the season. Aquatics is recording a 77% retention rate for lifeguards and pool managers returning for the summer. To date, we have 134 confirmed lifeguards — 10 are new hires. Aquatics continued to conduct interviews during March to fill remaining spots for summer operations.

Abbey Theater

The Abbey Theater hosted four sold-out shows for Karrer Middle School of "Newsies, Jr." in mid-February, followed by four sold out shows of "Imagine a Dragon" March 9-10.

"Our Town" premiered March 15 and ran through March 24. Thornton Wilder's timeless, Pulitzer Prizewinning drama of life set in the mythical village of Grover's Corners, New Hampshire, is an American classic with universal appeal. The simple story of a love affair between two young neighbors asks timeless questions about the meaning of love, life and death. It was recommended for ages 10 & up.



Update

Issues 2 Updates — Recreational Marijuana

Discussions on Issue 2 have been paused as both chambers prepare for their upcoming primaries, in addition to working on the Capital Budget/One Time Strategic Community Investment Fund.

Below is a breakdown of the bills that the legislature worked on at the end of 2023:

Senate Version — Sub. House Bill 86 (Rep. LaRe)

The Senate has incorporated their provisions into Sub. House Bill 86 and passed the bill off the Senate floor on December 6th, with a vote of 29-2. In order to become effective, the House will need to vote to concur on the Senate's changes. A concurrence vote has not yet been scheduled and Speaker Jason Stephens has indicated that the House will not be concurring. Should the House not concur, the bill will go to conference committee where both chambers can work out their differences. Governor DeWine has indicated that out of the various proposals, he is most supportive of Sub. House Bill 86.

Highlights of Sub. House Bill 86

Sets excise tax at 15%

 An increase from the voter-approved initiative to set the rate at 10%.

Sets the number of permittable plants per household at 6.

- A decrease from the voter-approved limit of 12. Allows Ohioans to possess up to 2.5 ounces of plant material and 15 grams of extracts.
- This is the same as the voter-approved initiative. Allows for expungement for individuals previously convicted of marijuana-related crimes that will be decriminalized.
- This was not included in the voter-approved initiative. Allows municipalities to prohibit or limit the home growth of marijuana.
- This was included in the voter-approved initiative. Allows employers to terminate or decline hiring individuals who use marijuana.
- This was not included in the voter-approved initiative. Allows counties, with voter approval, to levy a 3% excise tax to support local arts, culture, and entertainment.

House Version – House Bill 354 (Rep. Callender)

The House version, House Bill 354 (Rep. Callender), was introduced shortly after the passage of Issue 2 and is at the beginning stages of the legislative process. House Bill 354 has had numerous hearings in the House Finance Committee and will need to be voted out of committee and off the House floor before the Senate can begin considering the bill. Bill sponsor Jamie Callendar (R-Concord) has said that his version aligns more closely with what Ohioans voted On.

Highlights of House Bill 354

Sets excise tax at 10%

- This is the same as the voter-approved initiative. Levies a 10% tax on the gross receipts of licensed cultivators.
- This was not included in the voter-approved initiative. Sets the number of permittable plants per household at 12.
- This is the same as the voter-approved initiative. Allows Ohioans to possess up to 2.5 ounces of plant material and 15 grams of extracts.
- This is the same as the voter-approved initiative.

Redistricting Ballot Initiative for 2024

Background

Referred to as the "Citizens not Politicians Amendment" and is being worked on by Former GOP Ohio Supreme Court Chief Justice Maureen O'Connor and others.

The proposal would:

- Create a Citizens Redistricting Commission, comprised of five Democrats, five Republicans and five independents, to take up mapmaking.
- Bar current and former politicians, candidates, and lobbyists from serving on the new panel tasked with drawing district maps that "correspond closely to the statewide partisan preferences of the voters of Ohio."
- Establish a screening panel consisting of two retired
 Democratic judges and two retired Republican judges to review applicants for the redistricting commission. Appointment of the judicial panel would be overseen by the Ballot Board.
- The screening panel would then seek out a professional search firm to seek applications for the redistricting commission, create a pool of 90 qualified applicants, interview the candidates and select 45 finalists 15 Democrats, 15 Republicans and 15 independents. Of those 45, six would be randomly selected to serve on the redistricting commission at a public meeting.
- The initial members of the group would fill out the remaining slots via majority vote at a subsequent public meeting.

Status of Ballot Initiative

On Oct. 12, 2023, the Ohio Ballot Board unanimously found that the proposal constituted a single issue.

- On Oct. 25th, Citizens not Politicians realized that the summary language included the wrong date for when congressional and state legislative plans must be finished. Because of this mistake, the group will need to collect another 1,000 signatures and resubmit the language to Ohio Attorney General Yost's office for approval before they can move forward.
- They have until July 3, 2024 to collect the required number of signatures.
