2024/2025 City Council Goals

1

Become the Most Connected Community in the U.S.

Status: Construction continues in Phase 1. The permit status map can be <u>viewed here</u>. altafiber has mailed two general information pieces and is distributing door hangers. They also began direct marketing activities in July. Yard signs and a City of Dublin flyer have also been added as communication methods. The website has had 7,800+ project page views, 2,500+ residents have signed up for updates and now receive update newsletters, and a total of 1,538 residents have notified altafiber of having a dog fence and/or sprinkler system. This information will help altafiber coordinate how they enter a resident's yard when laying fiber in order to minimize impact on the resident. The first release of doors will occur on Sept. 13, 2024. This means they will offer internet services to the first 3,000 potential customers A fiber splicing event will take place 1-3 p.m., Sept. 14 in Coffman Park Pavilion. This public event will be centered around a live fiber splicing demonstration, conducted by altafiber's expert technicians. This demonstration will illustrate the advanced technology behind fiber optics and the crucial role it plays in modern telecommunications.

2

Realize the Metro Center Revitalization Vision

Status: Staff and the consultant continue to refine the preferred scenario based on Council's feedback July 1 and outline the sequencing needed for implementation. City staff members continue to engage with stakeholders in the area within and around Metro Center. The next anticipated review of information, including potential land acquisition discussion, is scheduled for the Sep. 30 City Council Work Session.

3

Implement the Parks and Recreation Master Plan

Status: City Council provided input on the 2025-2029 Capital Improvements Program (CIP) at the June 24 and Aug. 19 Council work sessions. The CIP includes funding for multiple larger-scale projects identified in the Parks and Recreation Master Plan, including the implementation of the DCRC Refresh, an update to the Riverside Crossing Park Master Plan and Amberleigh Park kayak launch renovations. At the July 1 City Council meeting, Council approved an historic strategic land acquisition of approximately 243 acres in the West Innovation District, which includes Carter Farms, Shepherd Excavating and SportsOhio. This land can be leveraged for several opportunities related to economic development, transportation enhancements and recreational expansions. Staff members continue working with the property owner to complete all tasks necessary for closing on the property. A steering committee is being formed to help guide the next steps to ensure optimal performance and sustainable operation of the sports complex.

4

Develop Dublin's "Destination of Choice" Next-Generation Community Events Vision

Status: Yard & Co. consultants began their "Stage 1: Explore" phase by visiting Dublin to attend the Dublin Irish Festival to meet and shadow Staff, conduct an engagement station at the Dublin Market and interview key stakeholders such as Dublin Chamber of Commerce, Dublin Arts Council and Visit Dublin. Yard & Co. will return in September to interview Council Members and additional stakeholders, including Crawford Hoying and the Historic Dublin Business Association. Town Square began the research necessary to provide a recommendation regarding the ownership and operating structures of a potential holiday market. A site visit is scheduled for Oct. 1 and 2 and will include interviews with key stakeholders, including partner organizations and Council Members. Both projects are expected to be complete in Q1 2025. The Summer Fun Series continued through August with more Games on the Green and Workout Wednesday classes. Workout Wednesdays will continue through Sept. 25.

Key Project Updates

STATUS
Altura Solutions completed the park facility assessments in late June. An online survey has been shared with local organizations such as Adaptive Sports Connection, Dublin Special Olympics and Dublin Miracle League. A virtual public engagement session will be held Sept. 25. The plan will include an assessment report and a transition plan to remove any identified barriers.
Construction began May 6 on both projects. Emerald Parkway roundabout construction has shifted traffic to the west and construction of the eastern half of the roundabout is nearing completion. Hardscape features are being installed. Bright Road construction is underway. Reconstruction of the southern half of the roadway and installation of underground utilities is ongoing. Bright Road eastbound traffic will be detoured until early September. Completion of the roundabout is planned for fall 2024 with the completion of the Bright Road Corridor following in fall 2025.
Applications for the preliminary development plan and rezoning considerations for the project site have been filed by COhatch and the City, respectively. Both are scheduled to be heard by the Architectural Review Board during its Sept. 25 meeting. The rezoning will require additional consideration by the Planning and Zoning Commission and a final determination by City Council, which is expected to take place in November 2024. The roadway network and streetscape design concepts are nearing completion, and coordination with area infrastructure improvements is ongoing.
Concepts were revised based on the feedback received by the Community Development Committee. Consultants are working on creating a mock-up of the aesthetic elements of the gateway sign and a complete fabrication of the entryway sign. he mock ups are expected to be ready this fall. Once available, staff members will bring the designs to City Council in Q4 2024.
Third-round working group meetings are being held and/or scheduled to address the four priority health needs as determined by the Advisory Committee and the CHNA report. These four working groups are focusing on: 1. Healthcare Navigation, 2. Transportation, 3. Youth Behavioral Health and Substance Abuse, and 4. Community Connections. The goal of the third-round working group meetings are to determine tasks and actions to address the prioritized objectives discussed. A final report is expected to be presented to City Council in Q4 2024.
The Envision Dublin Community Plan update was adopted by City Council July 1 and became effective Aug. 1. Staff and the consultant team are conducting a final review of the document for publishing. The Community Plan website was updated with an executive summary and digital document version.
Staff members are developing a comprehensive plan for electric vehicle charging infrastructure based on EV adoption rates, industry best practices and data from the City. The 90% report was submitted to the City and is under review. The final report is expected to be presented to City Council for review and adoption at the Oct. 7 meeting.



Dublin Community Recreation Center Refresh	MSA Design continues to work with Staff on phasing recommendations and sequencing work in preparation for bid package development. The Phase 1 bid package will be posted in the fall with bid acceptance planned for early November and work will begin in January 2025. The Phase 2 bid package will be bid in January 2025.
City of Columbus Fourth Water Plant - Transmission Main	A public meeting was held at the Dublin Community Recreation Center June 18. Dublin staff members will meet with City of Columbus to coordinate the project with other CIP initiatives. Design of the first transmission main will begin this summer with construction planned to start in 2026 and end in 2028. Construction of the second transmission main is expected to start in 2027 and end in 2030.
Curbside Management	Upciti cameras were installed on Longshore and North High streets in August for occupancy; duration; violations; vehicle and mode types; and sound levels data. Fybr pucks were also installed on North High Street near the West Plaza for occupancy, duration and double-parking information. Based on early recommendations in the draft plan, Longshore Street signs will be updated to include more active loading areas to reduce double-parking and improve pedestrian flows. The project completion is scheduled for Q3 2024, followed by a presentation to City Council.
Dublin Sustainability Plan	City Council reviewed the plan at the June 3 meeting. The consultant and staff members met to address comments from Council. The consultant provided a draft of an executive summary document for Council and the public. Staff members and the consultant team continue to work through the executive summary and final draft of the Sustainability Plan. The plan is expected to be reviewed by City Council for adoption in Q3 2024.
Post Road Interchange Construction	Construction is underway on the Post Road pavement under U.S. 33 and the U.S. 33 bridges over Post Road. The traffic signal at the Post Road and Hyland-Croy Road intersection was activated June 11. The new alignment of the U.S. 33 eastbound ramp to Post Road/S.R. 161 eastbound is open. Traffic will permanently use the Eiterman Road roundabout to access Post Road/S.R. 161 eastbound. Post Road/S.R. 161 is reduced to one lane in both directions underneath U.S. 33 through June 2025. Traffic on U.S. 33 is shifted while construction of the bridge takes place. All traffic movements will be available by the end of 2024. The project is anticipated to be completed by October 2025.
Riverside Crossing Park Master Plan	Based on feedback from City Council at the May 6 meeting, renderings were updated and shown to community members June 27 at a public open house. A Tell Dublin survey was launched that evening. Staff met with residents from the Bridge Park West condominiums July 25 at the request of the residents to provide clarification to the draft plan and answer questions. Input from this meeting will be included with all information gathered for the master planning process. A second public input session was held in Riverside Crossing Park Aug. 29. Staff members are reviewing the results of the more than 600 Tell Dublin survey responses and public meetings, incorporating feedback into the next round of renderings. Updates to the plan based on this feedback will be presented to City Council in Q4 2024.
The Emerald Connector	Demolition of the structure at 4130 Tuller Road was completed in June. The consultant team submitted a grant application for ODOT TRAC funding and an application for MORPC attributable funds and is coordinating with ODOT and the City of Columbus. The consultant is preparing the 30% design submission for September. A public engagement meeting is anticipated for Sept. 12. City Council received an update and reviewed aesthetic treatment options at the Aug. 12 meeting. Public comments for the TRAC application were collected through Aug. 16.






General Fund Revenue (by type) \$55,459,188

Highlights

Business Retention & Expansion

According to the Q2 2024 Trends Report by Colliers. Dublin continues to be a leader in the Columbus market in leasing activity. One of the trends that supports this is tenant migration. Tracking tenants' movement within the Greater Columbus Region shows Dublin is consistently in the top three submarkets for activity. In the second quarter of 2024, Dublin recorded the most new leases signed and the most renewals and expansions, surpassing neighboring submarkets such as Polaris, Westerville and Worthington. Dublin's commercial real estate market stands out for its strategic location within the thriving Columbus metropolitan area, attracting businesses seeking accessibility and growth opportunities. Its diverse mix of industries, robust economy and supportive business environment contribute to its sustained success in the commercial real estate sector.

Existing and prospective businesses should <u>request</u> a <u>meeting with our Economic Development Team</u> to learn more about the City's world-class amenities and concierge services.



The Dublin CIC Board met Aug. 1 to approve minutes, award a \$25,000 Commercial Facade Improvement Program Grant to 81 W. Bridge Street for restoration work related to windows and a lamp post, and approve the Strategic Plan created by Montrose Group LLC. Board Member and Economic Development Director Jeremiah Gracia presented the approved Dublin CIC strategic plan to Dublin City Council Aug. 12 for their awareness. The Dublin CIC's next meeting is scheduled for Oct. 21, where recommendations will be brought forward to execute action items related to the strategic plan.

JobsOhio/One Columbus Leads

The Economic Development team continues to manage and cultivate new business development relationships. Economic Development Director Jeremiah Gracia attended the Center for Automotive Research Management Briefing Seminars in Traverse City, Mich., alongside One Columbus and Marysville/ Union County. The City of Dublin continues to build relationships with leaders in the automotive industry. The partners focused on business attraction efforts and highlighting testing opportunities in The Beta District.

The Beta District

Traditional and social media engagement was strong in August following the appointment of Doug McCollough as The Beta District's first-ever executive director. The district's LinkedIn page gained 100 followers after the announcement, which led to a 16.8% increase from the previous month. Marketing activities continued, including billboards, digital advertising and media outreach. There have been nine leads so far in 2024.

An advisory board is being formed, which will include various partners, including from the local business community. Planning continued for the second annual Mobility in Color event, which is scheduled for Sept. 5 from 8 a.m. - 4 p.m. at Brick House Blue HQ (6605 Longshore St., Suite 240).

The Beta District was a featured topic at the Business Impact Breakfast with the Dublin, Union County and Logan County Chambers of Commerce. The event was held at the state-of-the-art Automotive & Mobility Innovation Center along the 33 Smart Mobility Corridor.

Boards & Commissions Activity

Boards & Commissions Activity

The Planning and Zoning Commission heard three cases in August. One of those cases, Irish Village, is a proposed mixed-use development consisting of +/-30,000 square feet of commercial space, 125-150 residential units and associated site improvements. The combined 11.86-acre site is zoned R-1, restricted suburban residential district and TF, technology flex district, and is located southwest of the intersection of Woerner Temple and Avery roads. The site has a recommended future land use of mixed-use neighborhood, which is intended to provide neighborhood services located near existing and future residential developments, and proposes uses such as office, personal services and commercial, as well as secondary residential uses.

The Architectural Review Board heard six cases in August. Vernacular is a small clothing boutique in Historic Dublin and is proposing the installation of a rear wall sign and a front-projecting sign, as well as associated exterior modifications such as stairway railing. The 0.02-acre site is zoned HD-HC, historic district core, and is located northwest of the intersection of South High Street and Spring Hill Lane. The site has a recommended future land use of mixed-use center, which is intended to provide a vibrant multi-use district organized around open space, with live-work opportunities, supporting services and various amenities.

The Board of Zoning Appeals heard two cases in August.

The Administrative Review Team did not meet in August

Regional Items of Interest

The Logan-Union- Champaign Regional Planning Commission met Aug. 8. Senior Planner Tammy Noble attended the Zoning and Subdivision Committee and the Executive Committee. There were three cases on the agenda, including one rezoning for Jerome Township, one rezoning for Richland Township and discussion of model text language for adult-use cannabis. The Jerome Township rezoning was the case with the closest proximity to Dublin, which rezoned 33.178 acres from commerce district to low-density residential which is a "downzoning." The rezoning is located on the south side of U.S. 42 and Currier Road and proposes the construction of single-family residential structures. The two cases were approved by both reviewing bodies and the model text language was discussed with more formal adoption expected in upcoming meetings.

The Delaware Regional Planning Commission heard seven cases at the June 27 meeting. The item most significant to the City of Dublin is a final plat for Liberty Trails at the northeast corner of Clark-Shaw and Liberty roads. It will be 17 residential lots on 30.1 acres and was approved on consent.

Compliance & Enforcement

Code Enforcement

Code Enforcement staff members continue to work with planning technicians to get certificate of zoning plan approval (CZPA) clearance for sheds, patios, fences and driveways. The team has observed that miscommunication occurs between residents and contractors. Contractors may indicate that a permit has been secured or that none is needed for the work proposed. Staff members make their best effort to communicate clarifying information to the resident before the work has begun or is completed. Information regarding the administrative permit process and when a permit is needed may be found here or by calling the Community Planning & Development Department at 614.410.4600.

Zoning & Code Compliance

Daily Zoning Inspections

In July, the department performed 46 daily zoning inspections. Daily inspections ensure compliance with zoning codes for completed construction projects including pool installations, solar panels, decks, new homes, and commercial new builds and additions.

Inspections included minor exterior alterations to the facades of 6768 Perimeter Loop and 6780 Coffman Road.

Routine Landscape Inspections

Ten landscape inspections were performed in July. Landscape inspections identify missing, dead or dying plant material and other zoning code violations. Inspections this month focused on commercial properties near Perimeter and Avery-Muirfield drives.

Certificate of Zoning Plan Approval (CZPA)

Sixteen CZPA inspections were performed in July to confirm compliance with approved CZPA permits.

Commercial and Residential Plan Review

Total plan review numbers were 69, which is typical for July. May was the highest month in the last 12-month period with 134 plan reviews. Overall plan review numbers are expected to increase during the summer months. An average of 78 plan reviews were completed per month over the last year.

New Building Permits Issued

Building permits issued (that required plan review) totaled 47 permits in July. Numbers can fluctuate +/- 10% each month. The monthly average, over the last 12-month period, was 43 new building permits issued per month, which is slightly above average.

Inspections

In July, the Building Standards team completed 702 inspections. Over the last 12-month period, the average number of inspections per month was 606. The number of inspections in July 2024 was 10% higher than July 2023. Data indicates there is an upward trend in the number of inspections completed year over year. In 2023, the division completed 7,000 building inspections.

Speed Management Implementation

- The first pilot location of tactical urbanism
 was installed in August at Avery and Jacana
 roads. Features of this location include white
 edge lines outlining solid color blocks and sloth icons
 at the entry/exits to the crosswalks with the Slow Down
 Dublin icon near the intersection.
- New driver feedback signs were installed on independent posts at Muirfield and Sells Mill drives for Scottish Corners Elementary's school zone. These new signs replace the previous sign assemblies co-located on the overhead mast arms with school flashers. Motorists now have multiple reminders of their speed and school zone speed limit.
- Initial noise level and traffic data collection in the Hard Road area was collected in August. Data will be collected three more times over different seasons for the study, with anticipated completion in 2025.

Serious Injury Crashes:

- A westbound vehicle on Post Road hit a vehicle stopped at a red light at Post Road and Kilgour Place/OCLC causing a serious injury.
- A southbound motorcycle on Riverside Drive ran off the road, hit a curb and struck a traffic sign pole resulting in a serious injury.
- A southbound driver on I-270 near milepost 16.2 left the road, hit a fence, trees and ditch embankment, resulting in a fatal injury due to medical complications while driving.

LinkUS

COTA held a media event in late July announcing the first Draft Transit Supportive Infrastructure Five-year Capital Improvements Program. Eighty-three projects are included across the Central Ohio region with two in Dublin: Blazer Parkway shared use path and transit stop improvements; Dale Drive shared use path; Dublin Road shared use path; and Shier Rings Road shared use path. The 30-day public comment period closed Aug. 23. Two virtual open houses were held Aug. 14 and 15 to share the plan with the public.

Sustainability


- Styrofoam collection boxes: To date, 5,868 pounds of Styrofoam have been diverted from the landfill.
- GoZero Composting: 33.917 tons of compost have been collected so far in 2024.
- Across the City's 21 electric vehicle charging stations, 44,751 gallons of gas have been saved to date in 2024. This equates to a greenhouse gas savings of 269,577 kilograms
- Management Analyst Emily Goliver was asked to serve on a subcommittee to review the Regional Sustainability Agenda by the Mid-Ohio Regional Planning Commission. The first subcommittee meeting was held in August.
- The next Document Destruction Day is scheduled to take place Nov. 2 at the Service Center.



Horticulture & Forestry

- Forty planted table decorations were prepared for the Emerald Club at the Dublin Irish Festival. Succulents from the planters were repurposed and used in conjunction with the City's internal wellness campaign. Nine other planted decorations were prepared and displayed on the Festival grounds.
- Staff members prepared 14 planters for Transportation
 Mobility for the Tactical Urbanism pilot project.
- Street tree pruning continues on Earlington Parkway.
- Cherry tree removals and stump grinding took place on Golden Place in preparation for fall replacements.

Asset Management & Quality Assurance



GoDublin

July saw 1,587 requests submitted for the month — an increase from 1,380 last month. Of those requests, 990 (62%) were initiated through the GoDublin app. By comparison, there were 1,578 requests in July 2023.

The top 10 requests generally account for 80% of all requests per month.

Inspections/Maintenance Work

- Inspections for pavement striping and marking inventory are ongoing.
- The 2024 pavement preventive maintenance program was updated and began in late August.
- Staff members are preparing to bid the sidewalk shaving program, which is planned to commence in early fall.
- The bike path root-grinding pilot program has successfully concluded. Staff members are pleased with the outcome and continue to receive compliments from residents.

Court Services - Highlights

- Received 361 traffic cases, nine operating a vehicle under the influence (OVI) cases and two criminal/code enforcement cases.
- Received six juvenile criminal diversion cases, three juvenile traffic diversion cases and 41 adult traffic diversion cases.
- Collected \$57,880.25 in fines and court costs.
- Collected \$344.25 in restitution for victims of crime.
- Diversion participants completed 38 hours of community service work.

DCRC Annual Shutdown

The DCRC closed for annual maintenance, cleaning and repairs Aug. 24 and will reopen Sept. 3. This 10-day window gives Staff and contractual vendors full access to clean ductwork and exhaust fans, complete high dusting building-wide, replace air handler units, install new underwater lights, and clean windows, carpets and drains, to name a few projects.

Healthy Brochure

The fall 2024 Healthy programs and activities guide was released Aug. 6. Registration for Dublin and school district residents took place Aug. 13 and, for non-residents, it began Aug. 20. Classes begin after Labor Day.

Dublin Rec App

Dublin Rec app downloads total 3,392 since launching May 22. Top clicks are membership scan-ins, group fitness schedules, indoor pool schedules and outdoor pool information. The app is also being used to communicate any changes in operations or hours.

Outdoor Pools Season Passes Sold: 6,585

Modified Pool Hours

Pool operations were consolidated to the Dublin Community Pool North as Dublin City Schools went back into session. The Dublin Community Pool South closed Aug. 14. All pass-holders were given access to the North Pool for the remainder of the season. Back-to-school hours are also in place and different from peak season to ensure efficient operations and staff. The North Pool and Ballantrae Spray Park will close for the season Sept. 2.

Pooch Pond

To celebrate the end of a successful pool season, dogs enjoyed a dip in the Dublin Community Pool South Aug. 15. The popular event was well-attended by residents and their four-legged friends.

Critical Incidents & Major Crimes

- After officers responded to a July 15 disturbance at Sonesta, police charged a man with three counts of aggravated menacing, assault and domestic violence. Among those incidents, the man pointed a firearm at hotel employees.
- Aug. 9, a Dublin man was charged with strangulation and violating a protection order after he strangled a woman in his home on Terrazza South Court.
- Aug. 19, officers responded to Wyandot Elementary on a swatting threat, which is a false alarm meant to draw a large emergency response to a certain address.

Dublin Irish Festival

The 37th Annual Dublin Irish Festival took place in August and despite having to suspend operations on both Friday and Saturday due to lightning, there were 77,000 people in attendance. Geraldine Byrne Nason, Ireland's ambassador to the United States, the first ambassador to visit the Festival, helped dedicate the event prior to Friday's suspension. Gaelic Storm brought country star Zac Brown to the Festival as a surprise guest on Friday night.





Permitted Events

There were 19 permitted events in August, including more cultural events in Riverside Crossing Park.

- Tier 1 events: 4; Tier 2 events: 15
- The Dublin Irish Festival 5K kicked off the month of permitted events with sold-out races of 1,000 5K runners and 150 Kids Dash participants in Historic Dublin.
- Pakistan Independence Day, Indian Independence Day, JASCO Japanese Summer Fest and the Arbaeen Walk highlighted the diverse community spirit in Dublin.
- The North Market Bridge Park Wine Fest took place Aug. 16-17 and brought in over 1,000 visitors during the two-day event.
- Speeding to Read and the Book Bash at the Bridge had another successful fundraiser in Bridge Park during their event Aug. 24. Hundreds of guests gathered in the streets to view luxury cars and listen to a concert.

Legislative

Update

Legislative Timeline

Both the Ohio House and Senate have recessed for the summer with plans to return in November after the general election takes place. While the House has not released their official schedule for the remainder of the General Assembly, the Senate is scheduled to return Nov. 13 to kick off the lame-duck session.

$\label{eq:house_bound} \mbox{House Bill 491} - \mbox{Requires Political Subdivisions to Participate in Ohio Checkbook Program}$

State Representative Tom Young (R-Dayton) and State Representative Bob Peterson (R-Sabina) introduced legislation that would mandate participation from cities and other political subdivisions in the Ohio Checkbook program. The bill has had two hearings in the House State & Local Government Committee. There has not been any proponent testimony, but the Ohio Rural Water Association provided opponent testimony June 11.

Spearheaded by former State Treasurer Josh Mandel nearly 10 years ago, the program aims to increase government financial transparency. Currently, participation from cities and other political subdivisions is voluntary. According to the bill sponsors' testimony, about 26% of Ohio's local governments have previously submitted expenditure data for publication on the website. Representative Peterson said that he views the legislation as a step toward improving relationships between Ohioans and the local governments that serve them.

House Bill 573 - Increases the Local Government Fund

State Representative Phil Robinson (D-Cuyahoga Co.) and Representative Juanita Brent (D-Cleveland) introduced House Bill 573, which would increase the percentage of state tax revenue allocated to the Local Government Fund from 1.7% to 3.68% beginning July 1, 2026. The bill has been referred to the House Finance Committee but has not received a hearing yet.

Pending Housing-Related Legislation

Senate Bill 244

Senate Bill 244 (Michele Reynolds, Hearcel Craig) has had two hearings in the Senate Ways & Means Committee. During the first hearing, the bill sponsors explained that the bill gives authority to cities and other political subdivisions to create and implement property tax relief programs (i.e., Residential Stability Zones) to not only help current homeowners in sustaining their homes, but also to "foster community resilience and cohesion."

On June 26, more than 16 individuals and groups provided proponent testimony before the Senate Ways & Means Committee. Proponents included the Franklin County Auditor, Ohio Municipal League, Cleveland City Council, Greater Ohio Policy Center and the MetroHealth System, among others.

Senate Bill 245

Senate Bill 245 (Reynolds, Craig), the Consumer Protection Bill, has had three hearings in the Select Committee on Housing where the bill sponsors and proponents of the bill have explained how the bill takes a comprehensive approach to ensure equitable treatment and due process for renters facing eviction and increase transparency and accountability in Ohio's real estate transactions and agreements. Proponents of the bill include the Ohio Realtors, Coalition on Homelessness and Housing in Ohio, Ohio Poverty Law Center and others.

The Ohio Real Estate Investors Association (OREIA) is currently the only group that has provided opponent testimony. OREIA Director of Government Affairs Dan Acton wrote in his opponent testimony: "OREIA appreciates the ongoing efforts of the sponsors and the committee to address the many housing issues facing Ohioans today ... However, OREIA has significant concerns with the bill's provisions eliminating the privacy and security protections afforded by legal LLC structures, and the potential unintended consequences of expanding eviction stays and record sealings. OREIA believes it is imperative that these issues be addressed before moving forward with the legislation."

Senate Bill 246

Senate Bill 246 (Reynolds, Craig) has been referred to the Senate General Government Committee but has not been scheduled for a hearing yet.

Issues 2 Updates — Recreational Marijuana

Legalized recreational marijuana sales in the state of Ohio officially began Aug. 6. The Division of Cannabis Control (DCC) announced that 98 dispensaries were awarded dual-use certificates of operation, allowing them to sell marijuana intended for both medical and recreational purposes. The deadline for sales to begin was originally set for Sept. 7, but the DCC Superintendent, James Canepa, attributed the early start to the "foundation laid through the state's existing Medical Marijuana Control Program." Within five days of sales beginning, more than \$11 million in sales took place.
