Letter from the City Manager

It is with great enthusiasm and renewed energy that we head into August 2024. July provided us with opportunities for celebration and recreation, while we continued to provide world-class services and also advanced numerous infrastructure improvements and strategic initiatives.

The historic purchase of 243 acres in the West Innovation District drew much excitement from the community, our partners and the local news media. Encompassing SportsOhio, Shepherd Excavating and Carter Farms, this investment marks a significant step in our efforts to foster economic development, transportation enhancements and recreational expansions, while supporting Council's Visionary Goals and strategic plans.

We were thrilled City Council adopted the Envision Dublin Community Plan update, which officially takes effect August 1. This capped 18 months of crossdivisional work and community engagement led by our Community Planning & Development team. We are thankful for Council's leadership and participation in the process, as well as the dedication of our steering committee. This new plan will guide how Dublin grows, develops and changes over the next ten years.

As always, Dublin's Independence Day Celebration was a highlight, bringing together residents to celebrate our nation's freedom. It was wonderful to see so many friends at the fishing derby, parade and evening celebration. Thanks to the tireless efforts of various City divisions and dedicated volunteers, the event was a resounding success.

We also kicked off the Dublin Summer Fun Series, which is bringing fitness and activities to Riverside Crossing Park. Residents and visitors are enjoying Workout Wednesdays, Games on the Green and Cinema Saturdays, which all are activating our newest park and bringing even more vibrancy to Downtown Dublin.



The fun continues this month with the world-renowned Dublin Irish Festival. The Festival celebrates our City's cultural diversity and heritage and attracts visitors, entertainers and educators from all over the globe, including our first visit from the Ambassador of Ireland to the United States of America. Ambassador Geraldine Byrne Nason, along with Vice Consul General Ellen Flanagan and Irish Honorary Consul in Ohio Mark Owens, will join us for the Festival dedication. We are looking forward to the festivities and committed to providing an unforgettable and safe experience for all.

Finally, in recognition of exceptional financial stewardship, the City of Dublin has received the highest credit rating from S&P Global Ratings, Fitch Ratings, Moody's Investor Service and KBRA. This was the first year that the City was reviewed by KBRA, and their rating makes Dublin the first and only city in the United States to earn four AAA ratings.

Thank you for your engagement with our community, and I eagerly look forward to your continued collaboration. I am confident that our collective efforts will continue to propel Dublin forward as we embrace the opportunities that lie ahead.

2024/2025 City Council Goals

1 Become the Most Connected Community in the U.S.

Status: Construction continues in Phase 1. Permit review and approvals continue for future phases. The construction phase planning map may be viewed here. In addition to continued collaboration on the resident communication plan, altafiber has mailed general information postcards and is distributing door hangers. They also began direct marketing activities in July. The website has had 6,800+ project page views, 2,370+ residents have signed up for updates and now receive update newsletters, and a total of 1,416 residents have notified altafiber of having a dog fence and/or sprinkler system. This information will help altafiber coordinate how they enter a resident's yard when laying fiber in order to minimize impact on the resident. The first release of doors will occur on Sept. 13, 2024. This means they will offer internet services to the first 3,000 potential customers.

Realize the Metro Center Revitalization Vision

Status: Staff and the consultant continue to refine the preferred scenario based on Council's feedback July 1 and outline the sequencing needed for implementation. The next anticipated review of information, including potential land acquisition discussion, is scheduled for August.

Implement the Parks and Recreation Master Plan

Status: City Council provided input on the 2025-2029 Capital Improvements Program (CIP) at the June 24 Council work session. The CIP includes funding for multiple larger-scale projects identified in the Parks and Recreation Master Plan (PRMP), including the implementation of the DCRC Refresh, an update to the Riverside Crossing Park Master Plan and Amberleigh Park kayak launch renovations. At the July 1 City Council meeting, Council approved an historic strategic land acquisition of approximately 243 acres in the West Innovation District, which includes Carter Farms, Shepherd Excavating and SportsOhio. This land can be leveraged for several opportunities related to economic development, transportation enhancements and recreational expansions. Staff members continue working with the property owner to complete all tasks necessary for closing on the property. A steering committee is being formed to help guide the next steps to ensure optimal performance and sustainable operation of the sports complex.

Develop Dublin's "Destination of Choice" Next-Generation Community Events Vision

Status: A contract with Yard & Co. for the Community Events Roadmap was executed in early July, followed by a kickoff meeting. Yard & Co. team members will attend the Dublin Irish Festival and meet with key technical staff. They will also visit the Dublin Market to survey residents about local events. A contract with Town Square was executed in July, and a launch meeting was held. The Dublin Summer Fun Series kicked off in July with the first Cinema Saturday. The fun will continue in August with more Games on the Green and Workout Wednesday classes.

Key Project Updates

PROJECT	STATUS
Dublin Parks Accessibility Plan	Altura Solutions completed the park facility assessments in late June. An online survey is ongoing and has been shared with local organizations such as Adaptive Sports Connection, Dublin Special Olympics and Dublin Miracle League. A virtual public engagement session will be held in September. City staff members will present findings to City Council at various stages of the process and bring the plan to Council for adoption once it is complete. The plan will include an assessment report and a transition plan to remove any identified barriers. The plan is scheduled to be completed in Q4 2024.
Bright Road Corridor Improvements and the Emerald Parkway/ Mount Carmel Roundabout	Construction began May 6 on both projects. Emerald Parkway roundabout construction has shifted traffic to the west and construction of the eastern half of the roundabout is nearing completion. Hardscape features are being installed. Bright Road construction is underway. Reconstruction of the southern half of the roadway and installation of underground utilities is ongoing. Emerald Parkway traffic has shifted into one lane in each direction for northbound and southbound travelers in the southbound lanes. Bright Road eastbound traffic will be detoured until September. Completion of the roundabout is planned for fall 2024 with the completion of the Bright Road Corridor following in fall 2025.
COhatch Headquarters	City Staff and consultants have met onsite with representatives from the private utilities to discuss undergrounding utility lines. A preliminary outline of associated improvements, including the number and potential locations of new transformers, is being prepared. The roadway network and streetscape design concepts for the project area are being finalized in coordination with the COhatch team. They are expected to be completed in time for formal project reviews (rezoning, and preliminary and final development plans) which will commence in September and conclude in December.
Community Gateway Signs	The concepts have been revised based on the feedback received by the Community Development Committee. The consultants are working on creating a mockup of the aesthetic elements of the gateway sign and a complete fabrication of the entryway sign. The mockups are expected to be ready in early fall. Once available, staff members will bring designs to City Council in Q3 2024.
Community Health Needs Assessment	Working groups have been formed to address the four priority health needs as determined by the Advisory Committee and the CHNA report. These four working groups are focusing on: 1. Healthcare Navigation, 2. Transportation, 3. Youth Behavioral Health and Substance Abuse, and 4. Community Connections. The second round of meetings was held mid-June and focused on prioritizing action steps, setting goals and beginning to detail a plan for implementing the prioritized actions. A third round of working group meetings will be scheduled once the follow-up work on the prioritized objectives is complete. A final report is expected to be presented to Council in Q3 2024.
Envision Dublin Community Plan Update	The Envision Dublin Community Plan update was adopted by City Council July 1 and will become effective Aug. 1. Staff and the consultant team are conducting a final review of the document for publishing. The Community Plan website will also be updated with an executive summary and digital document version.
EV Infrastructure Comprehensive Plan	Staff members are developing a comprehensive plan for electric vehicle charging infrastructure based on EV adoption rates, industry best practices and data from the City. The 90% report was submitted to the City and is under review. The final report is expected to be presented to City Council for review and adoption in October.



PROJECT	STATUS
Dublin Community Recreation Center Refresh	MSA Design continues to work on phasing recommendations. Phase 1 bid package to be posted in the fall with bid acceptance planned for early November.
City of Columbus Fourth Water Plant - Transmission Main	Columbus Staff and their consultant team briefed Council on the alignment study process at the May 20 City Council meeting. A public meeting was held at the Dublin Community Recreation Center June 18. Dublin staff members will meet with the City of Columbus to coordinate the project with other CIP initiatives. Design of the first transmission main will begin this summer with construction planned to start in 2026 and end in 2028. Construction of the second transmission main is expected to start in 2027 and end in 2030.
Curbside Management	The initial 12-month technology pilot projects are wrapping up and the study is being completed. Staff members are working on a new proposal with Fybr to place sensors detecting occupancy, duration and double-parking violations along North High Street. Efforts are being coordinated with Dublin Police. Staff members are also working with Derq to plan equipment and connectivity locations to begin collecting parking data along Riverside Drive and Bridge Park Avenue. Staff members are evaluating the loading zones on Longshore Street in Bridge Park to improve curbside operations and reduce double parking conflicts. Staff members are using data from Automotus, a technology parking company included as a partner in the pilot project phase of the Curbside Management Plan, to analyze parking behaviors and durations to determine appropriate wording for the signs and enforcement. A workshop with City staff members was held in May and staff are reviewing the draft report. The project completion will be presented to Council in Q3.
Dublin Sustainability Plan	City Council reviewed the plan at the June 3 meeting. The consultant and staff members met to address comments from Council. The consultant provided a draft of an executive summary document for Council and the public. Staff members provided feedback on the executive summary and are awaiting the final version. The plan is expected to be reviewed by City Council for adoption in Q3.
Post Road Interchange Construction	Construction is under way on the Post Road pavement under U.S. 33 and the U.S. 33 bridges over Post Road. The traffic signal at the Post Road and Hyland-Croy Road intersection was activated June 11. The new alignment of the U.S. 33 eastbound ramp to Post Road/S.R. 161 eastbound is open. Traffic will permanently use the Eiterman Road roundabout to access Post Road/S.R. 161 eastbound. Post Road/S.R. 161 is reduced to one lane in both directions underneath U.S. 33 through June 2025. Traffic on U.S. 33 is shifted while construction of the bridge takes place. All traffic movements will be available by the end of 2024. The project is anticipated to be completed by October 2025.
Riverside Crossing Park Master Plan	Based on feedback from City Council at the May 6 meeting, renderings were updated and shown to community members on June 27 at a public open house. A Tell Dublin survey was launched that evening. The next public input session will be held in Riverside Crossing Park Aug. 29. Staff members will then review the results of the more than 500 Tell Dublin survey responses and public meetings and incorporate feedback into the next round of renderings. Updates to the plan based on this feedback will be presented to City Council in Q4 2024. Staff members are targeting completion of the plan in Q1 2025.
The Emerald Connector	Demolition of the structure at 4130 Tuller Road and final grading and seeding were completed in June. The consultant team submitted a grant application for Ohio Department of Transportation (ODOT) Transportation Review Advisory Council (TRAC) funding and for MORPC's attributable funds with ODOT and the City of Columbus. The consultant is preparing the 30% design submission for August. Next steps are expected to include a review by City Council at the Aug. 12 meeting. A public engagement meeting is scheduled for Sept. 12.







Highlights



Business Retention & Expansion

On July 31, Economic Development and the Dublin Chamber of Commerce hosted the second annual Business Appreciation Event at Fado Pub & Kitchen. As a way to show appreciation and kick off the Dublin Irish Festival, attendees were provided complimentary tickets to the Festival.

City Council approved an Economic Development Agreement attracting Fallback Group LLC to Dublin. Fallback Group is a newly formed, Columbus-based motion picture company comprised of industry veterans and local investors. The project expects to create 49 jobs in the City of Dublin by Dec. 31, 2029.

Dublin-based businesses are encouraged to <u>request</u> a <u>meeting with our Economic Development Team</u> to learn more about the City's world-class amenities and concierge services.

International Business Development

The Economic Development team continues to manage and cultivate new international business development relationships. As a follow-up to the June 2024 trip to Taiwan, the team continues to be engaged with JobsOhio and attended a networking event hosted by JobsOhio to meet with international business representatives from Germany, France, Belgium, Italy, Sweden, India, Japan and Taiwan.

JobsOhio/One Columbus Leads

On June 13, the Economic Development team conducted a site visit for the SiteOhio certification program administered by JobsOhio. On behalf of JobsOhio, Insite Consulting provided valuable feedback to the City for the future positioning of sites in the West Innovation District. This process is also influential in the infrastructure grant application for the All Ohio Future Fund, which the City submitted to the Ohio Department of Development in mid-July for improvements in the West Innovation District.



OhioHealth Announces Major Expansion

OhioHealth announced a plan to launch an expansion of OhioHealth Dublin Methodist Hospital. The project is the largest planned expansion of Dublin Methodist Hospital since it opened in 2008. It will increase the hospital's inpatient and critical care capacity, which will create 200 permanent clinical jobs as well as hundreds of construction jobs.

Montrose Group is finalizing the CIC's strategic plan to be presented to the Community Improvement Corporation's Board for review and consideration at the August meeting. The strategic plan includes a report for each phase of the process, "Learn, Listen, Do." The "Learn" phase focused on reviewing the code of regulations and benchmarking analysis. The "Listen" phase consisted of interviews with each Dublin City Council Member. The "Do" or "Action" phase identified the objectives and strategies to achieve the goal of the CIC.



Where the future is tested in the Columbus Region

On July 17, the NW 33 Council of Governments met and named Doug McCollough The Beta District's first-ever executive director. In this role, McCollough is responsible for implementing the district's strategic plan and will play a key role in shaping its future. Prior to this appointment, McCollough served as the City of Dublin's CIO.

Marketing activities continued, including the production of new videos to raise brand awareness. Social media performance remained strong with a 150% increase in reactions, 16% increase in comments and 186% increase in page views.

Boards & Commissions Activity

Boards & Commissions Activity

The Planning and Zoning Commission heard three cases in July. One of those cases, Monterey Drive Concept Plan, is a proposed mixed-use development consisting of approximately 19,400 square feet of commercial space, 53 attached single-family units and associated site improvements. The 6.86-acre site is on both sides of Monterey Drive, south of the intersection with West Bridge Street. The site is zoned Bridge Street District-Historic Transition Neighborhood and has a recommended future land use of Mixed-Use Village Center, which is intended to provide commercial, office and mixed residential uses. The Commission recommended approval of the Concept Plan to City Council, citing support for the project and their appreciation for their engagement with the Waterford neighborhood.

The Architectural Review Board heard four cases in July. 16-22 N. High Street, proposing the construction of a new mixed use building in the Historic District consisting of one dwelling unit, a restaurant and office space. The 0.26-acre site is about 70 feet northeast of the intersection of North High Street and Bridge Street. Two historic buildings are on the site along with an existing shed and garage. The shed and garage would both be removed to make room for the new building. The new owner has been working carefully with staff to ensure that the proposed infill building is contextually appropriate with the National Register buildings already on the site. They are now making good progress, and this project provides an example of mixed-use infill development within the district.

The Administrative Review Team heard one case in July. This case was a minor project review for the removal of an existing ground sign and installation of a new 36 square-foot ground sign for an existing building in the Bridge Street District. It was approved at the ART meeting July 11.

The Board of Zoning Appeals did not meet in July.

Regional Items of Interest

In July, the Logan-Union-Champaign Regional Planning Commission (LUCRPC), both the Zoning and Subdivision committees and the Executive Committee met. The City of Dublin is also a member of the Budgetary Committee and Visioning Committee, which meet as needed. At the July 11 meeting, the two committees heard seven cases on each agenda. Four were plats and three were text amendments. The plats are technical documents and were approved either as preliminary plats or final plats. The three text amendments were for communities that are not in proximity to the City of Dublin, but included two townships adopting solar regulations based on model text compiled by LUCRPC, and on code amendments amending definitions related to nursing care facilities.

The Delaware Regional Planning Commission heard five cases at the June 27 meeting. A 12-month extension filing for a final plat for Painter Farm in Concord Township was recommended for approval. Painter Farm is an eight-lot residential subdivision on a private road located off Concord Road. The four cases presented following the extension are not in proximity to the City of Dublin.

Compliance & Enforcement

Code Enforcement

Ongoing Enforcement Efforts

Vehicle storage complaints, regarding RVs, boats and trailers in driveways or yards, are collected year-round, but are more commonly reported in warmer months as the owners transition storage arrangements. RVs and boats can be on a given site for a limited period before and after use with notification to City Staff. Visitors can store an RV in a driveway for 72 hours but cannot sleep in the vehicle. Code Enforcement works closely with homeowner and civic associations to review property maintenance and property condition issues. Code Enforcement also addresses exterior material storage violations that are visible from the right-of-way or adjacent properties. The team encourages property owners to report potential violations through the GoDublin app.

Zoning & Code Compliance

Daily Zoning Inspections

Forty-eight daily zoning inspections were performed in June. These daily inspections ensure compliance with zoning codes for completed construction projects including pool installations, solar panels, decks, new homes, and commercial new builds and additions. Inspections assessed minor exterior alterations at 75 N. High St. and 6620 Mooney St. Since April, there has been an increase in daily zoning inspections given the development of the Hyland Glen subdivision.

Routine Landscape Inspections

Eight landscape and six follow-up inspections were performed in June. Landscape inspections identify missing, dead or dying plant material and other zoning code violations.

Certificate of Zoning Plan Approval (CZPA)

Twenty-five CZPA inspections were performed in June to confirm compliance with approved CZPA permits.

Commercial and Residential Plan Review

Total plan review numbers were typical for the month of June with a total of 69. May was the highest month in the last 12-month period with 134 plan reviews. Overall plan review numbers are expected to increase during the summer months. An average of 81 plan reviews were completed per month over the last year.

New Building Permits Issued

Building permit issued numbers (that required plan review) totaled 36 permits in June. Numbers can fluctuate +/- 10% each month. The monthly average, over the last 12-month period, was 42 new building permits issued per month, which is slightly above average.

Building Standards Performance Measures.

Inspections

In June, the Building Standards team completed 634 inspections. Over the last 12-month period, the average number of inspections per month was about 600. The number of inspections in June 2024 was 3% higher than June 2023. Data indicates there is an upward trend in the number of inspections completed year over year. In 2023, the division completed 7,000 building inspections.

Transportation & Mobility




Speed Management — Driver Feedback Signs and Speed Trailer Deployment

- Year to date, Transportation & Mobility (T&M) driver feedback signs have rotated among 31 locations throughout the Dublin community including Tara Hill Drive, Tullymore Drive, Sells Mill Drive and Avery Road.
- Of the locations, 80% are included in the annual driver feedback sign schedule, 13% are on-demand requests from residents and 7% are construction-related.
- The third set of driver feedback signs received this March has been used 67% of the time, while the first two sets continue to be deployed 100% of the time.
- In partnership with T&M, Dublin Police have completed 80 speed trailer deployments to date this year using seven speed trailer units.

Bikeway Policy and Facilities Update

• T&M Staff completed a bikeway audit of the planned recreation bike loop to document existing signs and pavement markings; identify areas of safety concerns for the consultant on the project; and to pinpoint locations for removal of honeysuckle and hazardous tree branches. The route was selected based on past honeysuckle removals and to prepare for the deployment of secondary wayfinding signs and pavement markings.





The next bikeway audit is scheduled for Aug. 22, 2024, along the Emerald Trail.

- Irrigation maintenance and irrigation head replacements continue on park systems.
- Staff members continue to perform bike path trimming citywide.

Sustainability

- Styrofoam collection boxes: To date, 5,220 pounds of Styrofoam have been diverted from the landfill.
- GoZero Composting: 29.48 tons of compost have been collected so far in 2024.
- Across the City's 21 electric vehicle charging stations, 36,593 gallons of gas have been saved to date in 2024. This equates to a greenhouse gas savings of 220,436 kilograms

- Approximately 913 pounds of material was diverted from the landfill at the 2024 Independence Day Evening Celebration, nearly double the amount diverted at last year's event.



Legislative

Update

Legislative Timeline

Both the Ohio House and Ohio Senate have recessed for the summer with plans to return in November after the general election takes place. While the House has not released their official schedule for the remainder of the General Assembly, the Senate is scheduled to return on Wednesday, Nov, 13 to kick off the lame duck session.

$\label{eq:continuous} \mbox{House Bill 491} - \mbox{Requires Political Subdivisions to Participate in Ohio Checkbook Program$

State Representative Tom Young (R-Dayton) and State Representative Bob Peterson (R-Sabina) introduced legislation that would mandate participation from cities and other political subdivisions in the Ohio Checkbook program. The bill has had two hearings in the House State & Local Government Committee. There has not been any proponent testimony, but the Ohio Rural Water Association provided opponent testimony on June 11.

Spearheaded by former State Treasurer Josh Mandel nearly 10 years ago, the program aims to increase government financial transparency. Currently, participation from cities and other political subdivisions is voluntary. According to the bill sponsors' testimony, about 26% of Ohio's local governments have previously submitted expenditure data for publication on the website. Representative Peterson said that he views the legislation as a step toward improving relationships between Ohioans and the local governments that serve them.

House Bill 573 - Increases the Local Government Fund

State Representative Phil Robinson (D-Cuyahoga Co.) and Representative Juanita Brent (D-Cleveland) introduced House Bill 573, which would increase the percentage of state tax revenue allocated to the Local Government Fund from 1.7% to 3.68% beginning July 1, 2026. The bill has been referred to the House Finance Committee but has not received a hearing yet.

Pending Housing-Related Legislation

Senate Bill 244

Senate Bill 244 (Reynolds, Craig) has had two hearings in the Senate Ways & Means Committee. During the first hearing, the bill sponsors explained that the bill gives authority to cities and other political subdivisions to create and implement property tax relief programs (i.e. Residential Stability Zones) to not only help current homeowners in sustaining their homes, but also to "foster community resilience and cohesion."

On June 26, more than 16 individuals and groups provided proponent testimony before the Senate Ways & Means Committee. Proponents included the Franklin County Auditor, Ohio Municipal League, Cleveland City Council, Greater Ohio Policy Center, and the MetroHealth System, among others.

Senate Bill 244

Senate Bill 245

Senate Bill 245 (Reynolds, Craig), the Consumer Protection Bill, has had three hearings in the Select Committee on Housing where the bill sponsors and proponents of the bill have explained how the bill takes a comprehensive approach to ensure equitable treatment and due process for renters facing eviction and increase transparency and accountability in Ohio's real estate transactions and agreements. Proponents of the bill include the Ohio Realtors, Coalition on Homelessness and Housing in Ohio, Ohio Poverty Law Center, and others.


The Ohio Real Estate Investors Association (OREI) is currently the only group that has provided opponent testimony. OREIA Director of Government Affairs Dan Acton wrote in his opponent testimony: "OREIA appreciates the ongoing efforts of the sponsors and the committee to address the many housing issues facing Ohioans today.... However, OREIA has significant concerns with the bill's provisions eliminating the privacy and security protections afforded by legal LLC structures, and the potential unintended consequences of expanding eviction stays and record sealings. OREIA believes it is imperative that these issues be addressed before moving forward with the legislation."

Senate Bill 246

Senate Bill 246 (Reynolds, Craig) has been referred to the Senate General Government Committee but has not been scheduled for a hearing yet.
