- 1) The applicant continue to work with Planning and Engineering such that comments are addressed during the required site permit review process.



RESULT: The Commission was generally supportive of the use and activation of the corner. Concerns were raised regarding the building’s proximity to Sawmill Road, impact on trees, and the suburban character of the proposed structure. Commission members encouraged the applicant to consider a taller building to anchor the corner and emphasized the importance of pedestrian circulation and activity.
