SEAN COTTER, CHAIR REPORT

2024 was a busy year for the Architectural Review Board (ARB), with a total of eleven meetings, one training session, and a joint meeting with the City Council. The Board reviewed a significant number of cases, reflecting the high level of interest in living, working, and investing in the Historic Dublin area. In total, we had 34 cases for the year, generally split between residential and business, along with 17 administrative actions. The strong collaboration between the City, the Board, and property owners helps to ensure the vitality of the Historic District.

KEY HIGHLIGHTS:

COHATCH DEVELOPMENT

After a series of review meetings, final approval was granted for a major redevelopment of the North Riverview area. This investment will revitalize and bring new uses to this area.

NORTH HIGH

The first Informal review of the 72-84 North High, also known as Oscar's, was conducted to gain initial insights into the new property owner's vision.

MINOR PROJECTS

The Board continued to review and approve residential and business minor projects to ensure they are appropriate for the Historic District.

STREAMLINED PROCESSES

Over the last 1-2 years, property owners have requested a more efficient approach to project review. To streamline the process, the planning staff undertook a review of the Historic District Code and Historic Design Guidelines. After input from the ARB and the Planning and Zoning Commission, the modified Historic Code and Guidelines were approved by City Council and made effective in December. These changes, along with improvements made last year, will aid businesses and homeowners during projects in the Historic District.

This year, the Board bid farewell to Gary Alexander, who served on the Board for seven years and acted as chairman for over three years. The City Council appointed Lisa Patt-McDaniel as Gary's replacement.

BOARD MEMBERS



SEAN COTTER, CHAIR

I have spent nearly 25 years in Dublin with my wife Lisa and our two daughters, Anna and Erin. However, in 2010 we said goodbye to Dublin and hello to the mountains when we moved to Switzerland for a 3 1/2year short-term work assignment. This experience gave me and my family an opportunity to see the world from a new perspective, while also giving us a chance to see home in a new way.

I want to serve because I believe in the power of community-led problem solving, and that close collaboration between the people and the government leads to a strong community. This interest spurred me to apply for and ultimately get appointed to the Board of Zoning Appeals in 2007. This rewarding experience reinforced my view that close interaction with people makes government more responsive to the citizens. After our return from Switzerland, I again felt a call to serve and had the good fortune to be appointed to the Architectural Review Board. HILARY DAMASER, VICE CHAIR

I am currently a Principal Assistant Ohio Attorney General in the Executive Agencies Section of the Ohio Attorney General's Office. In this position, I represent various State agencies, boards, and commissions, including the Departments of Administrative Services and Commerce, the Ohio Expositions Commission, and the Ohio Arts Council. Previously, I worked as a staff attorney for Justice Alice Robie Resnick of the Supreme Court of Ohio and for Judge Peter B. Abele of the Ohio Fourth District Court of Appeals. I am certified by the Ohio State Bar Association as a specialist in Administrative Agency Law. As a side project, I enjoy researching Nettie Cronise Lutes and Florence Cronise, Ohio's first women attorneys and have portrayed the Cronise sisters and Justice Florence Allen, Ohio's first woman Supreme Court justice, at various occasions for the Ohio Historical Society and for the Supreme Court of Ohio. I have served as a member of the Board of our synagogue Congregation Beth Tikvah in Worthington and am currently a member of the Board of the Ohio State Bar Foundation.

Ever since moving to Dublin from northwest Columbus (just across the river) six years ago, our family has felt warmly welcomed by the community. OVERVIEW AND RESPONSIBILITIES



OVERVIEW

As part of the operations of the Architectural Review Board (ARB), an annual report is prepared for City Council to serve as a review of the Board's activities, cases, decisions, and special projects.

Over the past year, the Board has reviewed and made determinations on numerous developments within their reviewing authority.

RESPONSIBILITY


The ARB's purview includes properties within the desigated Historic District outlined in yellow on the map (upper right), and specific historic properties outside of the District that are identified on Appendix G (lower right map) within the Zoning Code. Most of these properties are landmarks and examples of early architecture in Dublin, and all add to the character of the City. The Board seeks to maintain the historic value of each of them.

The responsibilities of the ARB are to preserve architectural and cultural resources and to make recommendations regarding related development proposals. The Board reviews new construction projects, alterations to historic resources and demolition of resources. The Board's activities promote the educational, cultural, and economic well-being of the community through the preservation and maintenance of the Historic District and Appendix G resources.

The Planning Division supports the Board in these operational activities through case management and review; facilitated training and development for members; and as a liaison between the public, staff, and other Boards, Commissions, and City Council.

ARB ACTIVITIES

ADMINISTRATIVE

The Board continued to execute their responsibilities with Sean Cotter elected as Chair, and Hilary Damaser elected as Vice-Chair. A new member, Lisa Patt-McDaniel, was appointed to the Board. Martha Cooper and Michael Jewell have continued to serve. On the staff side, Sarah Holt, Senior Planner is the Board Liaison.

PUBLIC MEETINGS

The Board continues to live stream all meetings, which are held at Council Chambers and open to the public. The ARB conducted 11 regularly scheduled meetings and one joint training session with City Council.

CASE REVIEWS

In 2024, the Board reviewed **34 new cases** which varied in scope from major projects to individual signs. This is a much higher number than recent years.




Figure 1: Case Type 2024




Figure 2: Caseload Comparison: 2022-2024

Figure 1 below shows the number of new cases by type over the last year, illustrating the range of projects that came before the Board. This included complex cases such as the COhatch Riverview Village Development and important considerations, such as the Historic District Code Amendment. **Figure 2** below shows the case load compared to previous years.

SPECIAL **PROJECTS**



COHATCH RIVERVIEW VILLAGE

The transformation of North Riverview Street continues with the development of Riverview Village through a partnership between COhatch and the City. The Architectural Review Board, Planning and Zoning Commission, and City Council reviewed and approved the rezoning of the area to Historic Core and the Architectural Review Board approved both the Preliminary and Final Development Plans for the site in autumn.

Riverview Village is located between North Street, Wing Hill Lane, and N. Riverview Street and will feature COhatch's corporate headquarters, a restaurant, public plaza, kiosk, sidewalks, bike parking, and staircases for greater community access to the riverfront.

A new COhatch building will provide additional access to the riverfront and outdoor spaces along the east side of N. Riverview.

ARB FORWARD-THINKING NEWS



2024 HERITAGE OHIO ANNUAL CONFERENCE

In October, staff member Taylor Mullinax attended the 2024 Heritage Ohio Conference in Newark, Ohio. The event was hosted by Heritage Ohio and the theme this year was "World Heritage through the Heartland" in recognition of the UNESCO World Heritage designation of several sites throughout the state, including the Hopewell Mounds.

The conference included guided tours of the nearly restored Newark Arcade and the Dawes Arboretum; educational sessions on historic codes and guidelines; highlights of Main Street initiatives and development; and narratives on natural landscapes, cemetaries, and churches.

Staff attended the Keynote Presentation by Chief Billy Friend, as well as Planning for the Future: Licking County Framework and Main Street 101. Staff also toured the Newark Earthworks and the Newark Arcade.

HISTORIC DISTRICT CODE AND GUIDELINES

After the completion of the 2023 Code update, staff initiated a Phase II portion for 2024. There were two Phase II goals identified during public meetings in 2023: make the process simpler where possible and provide direction for Background buildings. With the adoption of the Phase II effort by City Council in November of 2024, these goals have been realized.

One of the most exciting changes is the expansion of the number and type of Administrative Approvals (AA) from 11 to 19, including signs not needing a Master Sign Plan. This will save applicants, staff, and the Board significant time, allowing businesses to receive their signage as soon as they are ready. Staff expressed appreciation for the trust and faith of the Board in pursuing these changes. Staff will continue to report to the Board quarterly on approved AAs.

The Guidelines now provide additional direction on Background buildings. Staff found that there are essential elements that are key to maintaining the character of the Historic District.

These are continuity of height, setbacks, massing, roof shape, window and door openings, eaves, and overhangs. By taking cues from adjacent buildings, Background resources, including new construction, can be more sympathetic to their surroundings. Where Background buildings are adjacent to Landmark resources, there will be a higher level of evaluation, including materials and other stylistic features.

Staff also saw an opportunity to address a cumbersome Administrative Departure, Waiver, and Variance process, which previously involved two different boards. Now, all requested departures from Code criteria are deemed "Waivers", with ARB as the single source for approvals.

As a part of this effort, staff along with Greg Dale, FAICP, and Max Merritt of McBride, Dale, Clarion helped with language and ensuring that the goals of the Phase II effort were met. The new Code and Guidelines are on the Historic District's webpage as of December 18, 2024.
