

Waterways Maintenance Program

2025 Project Information

Dear Resident,

The City of Dublin wishes to inform you of the upcoming Waterways Maintenance Program 2025 Project construction. The Project includes improving bank stabilization for the following eight stream sites across the City:

- Site 3: Tamarisk Creek, north of Tonti Drive, east of Red Bay Court
- Site 18: South Fork Indian Run, within Darree Fields
- Site 22: South Fork Indian Run, north of Post Road, east of Avery-Muirfield Drive
- Site 24: Bait Shop Creek, south of Tonti Drive, east of Riverside Drive
- Site 25, 27, and 28: Tonti Creek, south of Wyandotte Woods Boulevard, west of Lanham Court
- Site 44: North Fork Indian Run, north of Brand Road, west of Shannon Glen Boulevard

The Project consists of clearing and grading activities, stream bank reshaping and stabilization and riprap, native material and erosion protection matting installation. The Project also includes the installation of temporary sediment controls, permanent stabilization of disturbed areas and riparian buffer zone plantings to enhance channel stability.

The proper maintenance and operation of our waterways are essential to ensure effective stormwater conveyance and to reduce flooding risks and infrastructure damage caused by channel erosion. By addressing erosion and stabilizing stream banks, the Project will help decrease sediment loading, improve aquatic habitats and enhance overall water quality.

Tentative Schedule

The City has contracted on this project with Brennstuhl Construction, Inc., who intends to begin work the week of January 5, 2026 with site recordings

and survey, but will proceed with construction per the following schedule:

- Site 24: Jan. 6, 2026
- Site 18: Jan. 7, 2026
- Site 3: Jan. 13, 2026
- Site 22: Jan. 22, 2026
- Site 44: Jan. 22, 2026
- Site 25, 27, 28: Feb. 11, 2026

The Project is expected to be completed by May 1, 2026. Please note the construction schedule is weather-dependent and subject to change. Weather-sensitive work, such as plantings and site restoration, will occur in Spring 2026. Construction hours are generally 7 a.m. to 6 p.m.

Construction Impacts

One lane, two-way traffic control and sidewalk closures may occur for short durations during the Project. You will have access to your driveway at all times. Brennstuhl Construction, Inc. will not enter upon or disturb your property, unless your property has an existing easement or if the City has acquired a temporary or permanent easement from you.

What about City services?

There will be no changes in your emergency services. The police and fire departments will be notified of all traffic restrictions. Yard waste, garbage and recycling collections should continue according to their regular pick-up schedules unless you are advised otherwise.
