

Master Sign Plan - 72-84 North High Street, and 20 North Street, Introduction Narrative:

The project includes several buildings, each with multiple tenants. A comprehensive plan for the identification and orientation signage for the complex will provide the design intent, and framework for design control, for a unified graphic information system.

The Master Sign Plan includes orientation signage (main directories for site orientation), localized directories and tenant signage for a unified wayfinding system.

The main project directories, located at the southwest and southeast corners of the site, are designed as corner markers and reference stone corner posts such as the post directly south of the site at 56 North High Street.

The localized directories and tenant signage are designed to reflect architectural details and color schemes of the buildings on which they are placed.

The quantity and placement of signage elements is specifically limited to that signage required for orientation and tenant identification.

The two main directories, as proposed, will require a Right of Way waiver or agreement (we may be able to place the east marker within our site, but near the ROW). The southwest directory if placed per the signage ordinance, would be deep into the planting beds of the 74 building, concealed by a tree and historic stone wall. We propose to place the directory in relation to the corner, similar to the stone pillar directly south.

The proposal aligns with the guidelines generally as follows:

1. Size of signs appears to align with code.
2. All signage is to be externally illuminated with architectural gooseneck type lighting (except main directories).
3. All materials are sculpted, routed with dimension in relief.
4. Forethought to placement and location has been addressed with symmetry to building openings and features.
5. Colors and visual themes are in balance with building both in finish and materials
6. The proposed signs respond to context and character for this redevelopment and demonstrate continuity with surrounding district.

The proposal deviates from guidelines generally as follows:

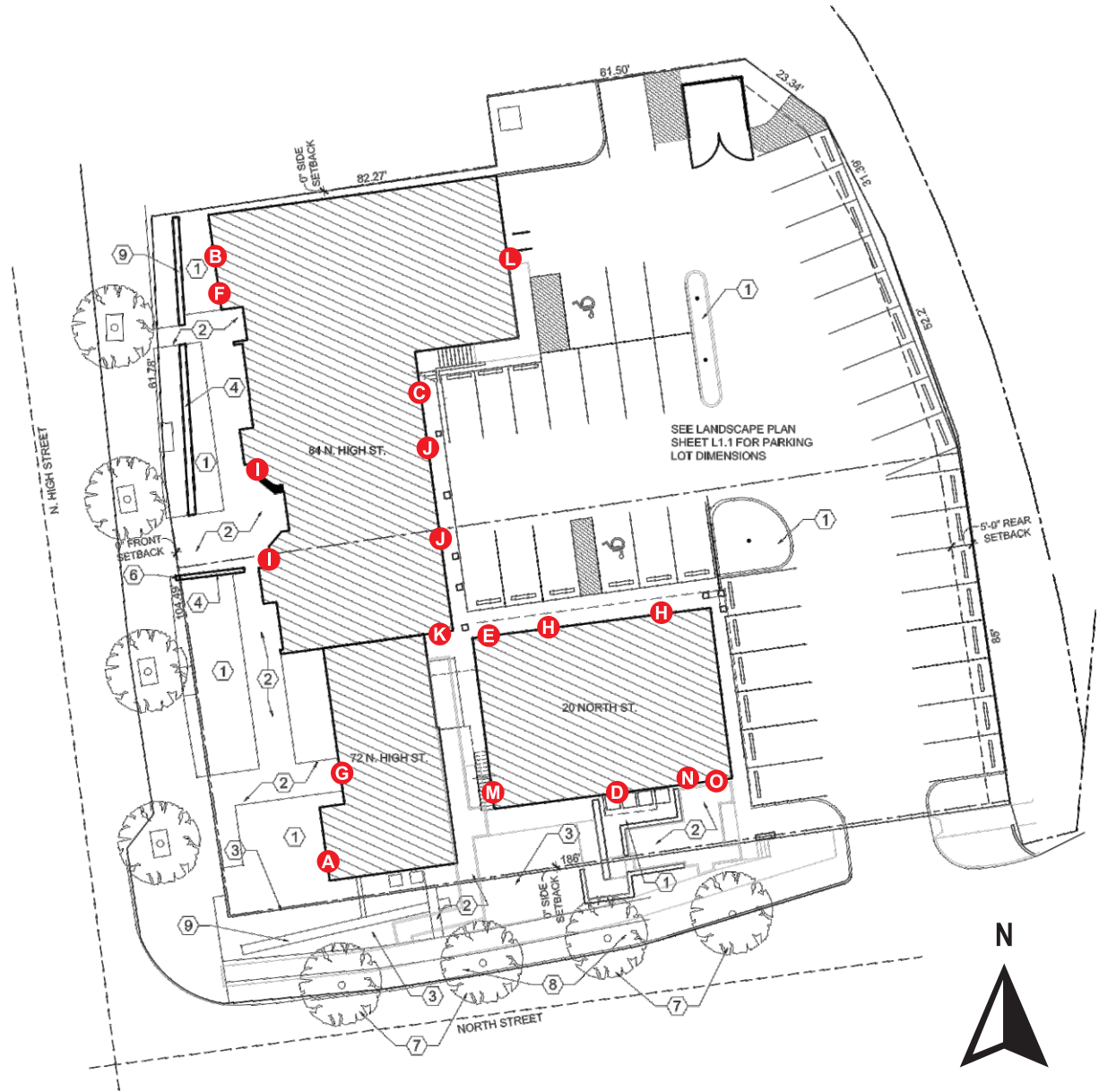
1. Code allows for signs mounted up to 15' in building elevation. Part of this application may require deviance specifically for signage in the east elevation and south elevation of 20 North Street Building.
2. Code allows for 1 sign per building or use. A deviance is required here for multiple wayfinding requirements that are explicitly functional
3. Ground signs are permitted In lieu of wall signs . This plan deviates here given the need for multi-tenant directional wayfinding signage
4. Ground signs are required to be at an 8' setback from right of way. The placement of the two proposed directory ground signs will be most effective if we can place them near, or slightly in the ROW. As described above, we have an opportunity to reflect the stone pier of the south east corner of North Street and High Street intersection.

Graphics Plan

This comprehensive site plan is designed to provide functional, attractive dimensional themed signage for the development.

To include:

- Color coordination with pre-approved building colors and trim.
- Design intent themed with architectural features.
- Directories to include multi-tenant listings all to have consistent font and color.
- Tenant identification signage to be functionally placed.
- Intent to provide contrasting colors to optimize function.
- Signage to be externally illuminated as required.
