Electrical Permit - New/Additions/Alterations	\$120.00 for first 1,000 square feet plus \$165.00 each additional 1,000 sf or fraction thereof up to 50,000 plus \$115.00 each additional 1,000 sf or fraction thereof up to 100,000 plus \$95.00 each additional 1,000 sf or fraction thereof over 100,000
Electrical Permit – Low Voltage*	\$75.00 for first 1,000 square feet plus \$65.00 each additional 1,000 square feet or fraction thereof
HVAC Permit – New/Additions	\$140.00 for first 1,000 square feet plus \$65.00 each additional 1,000 square feet or fraction thereof
HVAC Permit – Alterations	\$120.00 for first 1,000 square feet plus \$40.00 each additional 1,000 square feet or fraction thereof
HVAC Replacement Permit	\$140.00 per unit (each furnace and ac)
Gas Line Permit	\$135.00
Fire Protection Permit	\$425.00 plus low voltage fee \$185.00 per minor revision, major revision not offered
Temporary Structure Permit	\$165.00 + WTFD Fee per schedule
Change of Use Permit	\$390.00
Demolition Permit (Review & Inspection)	\$470.00
Commercial Hood Permit	\$450.00 if reviewed separately
Permanent Sign Plan Review & Inspection	\$495.00
Other Building Permits/Fees not listed	See Schedule C or City Ordinance

***Low voltage** not required if operating less than 25 volts and supplying under 50 watts of energy.
