Re:	Walgreen Co. DBA Walgreens 06115 Change of Corporate Stock Ownership – C1 & C2 Liquor Permits

I. INTRODUCTION

The City of Dublin recently received a Notice to Legislative Authority ("Notice") from the Ohio Division of Liquor Control regarding Walgreen Co. DBA Walgreens 06115 ("Walgreens"). The Ohio Division of Liquor Control (the "Division") requires that liquor permit holders notify the Division when there is a change of corporate stock ownership. Walgreens currently holds a C1 and C2 liquor permit, and submitted an application for change of corporate stock ownership. Dublin has received this Notice pursuant to R.C. 4303.26 because the location for the permit premises is within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permits.

II. <u>BACKGROUND</u>

Walgreens is a foreign corporation that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 6805 Hospital Drive, Dublin, Ohio 43016, which is located just west of Avery-Muirfield Drive, in front of the Avery Road Retail Center. Walgreens currently holds two liquor permits at this location: a C1 permit, which permits the sale of beer in sealed containers for carry out only; and a C2 permit, which permits the sale of wine and mixed beverages in sealed containers for carry out.

Walgreens submitted its application due to a change in stock ownership. This change likely has no effect on its liquor permits, but notification of such change is required by the Division. The application is currently pending before the Division.

According to the Division's records, Walgreens does not have a history of violating Ohio liquor laws. The change in stock ownership should have no impact on its clean history with the Division.

RECOMMENDATION

It would appear that it is unnecessary to request a hearing in this matter. Walgreens does not have a history of violating Ohio liquor laws and the change in stock ownership should not change that. Regardless of whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control by August 29, 2016.

Retail Store Carryout Permit Class Permit Fee Description C1 \$252 ORC 4303.11 Beer only in original sealed container for carry out only. C2 \$376 ORC 4303.12 Wine and mixed beverages in sealed containers for carry out.

4303.11 C-1 permit.

Permit C-1 may be issued to the owner or operator of a retail store to sell beer in containers and not for consumption on the premises where sold in original containers having a capacity of not more than five and one-sixth gallons. The fee for this permit is two hundred fifty-two dollars for each location.

4303.12 C-2 permit.

Permit C-2 may be issued to the owner or operator of a retail store to sell wine in sealed containers only and not for consumption on the premises where sold in original containers. The holder of this permit may also sell and distribute in original packages and not for consumption on the premises where sold or for resale, prepared and bottled highballs, cocktails, cordials, and other mixed beverages manufactured and distributed by holders of A-4 and B-4 permits, and containing not less than four per cent of alcohol by volume, and not more than twenty-one per cent of alcohol by volume. The fee for this permit is three hundred seventy-six dollars for each location.
