Re: Resolution 04-17 – A Resolution Declaring Certain City-Owned Property As

Surplus and Authorizing the City Manager to Dispose of Said Property in

Accordance with Section 37.07 of the Dublin Codified Ordinances

Summary

Section 37.07 of the Dublin Codified Ordinances requires City Council authorization for disposal of all assets or other property valued at \$5,000 or above. Resolution 04-17 authorizes the City Manager to dispose of certain vehicles and equipment that are planned for replacement in 2017 as they reach the end of their useful life for City purposes.

The City's vehicles and equipment replacement schedule is established by thorough analysis of the history of the vehicle. The FASTER fleet management software provides staff with the information that is used as part of the vehicle and equipment evaluation process, including: original cost, depreciation, preventive maintenance, scheduled corrective maintenance, unscheduled maintenance, and miles/hours used. Before these assets are taken out of service, a final evaluation will be completed as to current condition and maintenance history. If, after the evaluation, the asset is determined to have had minimal maintenance costs and staff believes the asset provides continued value to the City, the asset will be maintained as part of the City's fleet and the replacement schedule will be modified accordingly.

Programming of replacement fleet vehicles and equipment is included in the approved 2017-2021 Capital Improvements Program (CIP). The complete list of vehicles and equipment that have been identified and budgeted for replacement in 2017 are listed in the attached exhibit.

As the vehicle and equipment assets are replaced, they will be posted on the City of Dublin website, together with a link to take customers directly to the auction website at www.GovDeals.com. Under the terms of the City's agreement with GovDeals, the City will pay a commission to GovDeals of 7.5% of sale proceeds; however, the City will incur no cost unless the items are sold. The GovDeals site is well-known among public entities and will provide a broad pool of prospective buyers for City surplus items.

Recommendation

Staff recommends adoption of Resolution No. 04-17 declaring certain City-owned property as surplus and authorizing the City Manager to dispose of said property in accordance with Section 37.07 of the Dublin Codified Ordinances at the January 23, 2017 Council meeting.
