Re: Resolution 45 -17 - Bid Acceptance for 2017 Parking Lot and Shared-

**Use Path Maintenance Program** 

#### Summary

On May 24, 2017, three (3) bids were received, publicly opened, and read for the 2017 Parking Lot and Shared-Use Path Maintenance Program. The Engineer's estimate is \$675,500. The following parking lots will be rehabilitated this year: the three on the south side of Coffman Park Drive (adjacent to the tennis courts, playground and amphitheater), the northern portion of the South Pool lot, the Ballantrae Park lot, and the Dublin Arts Council lot. The shared-use path work includes asphalt repair and/or replacement and seal coating at various locations. The attached map shows the locations of the lots and the shared-use paths included in the maintenance program for this year. A copy of the construction drawings have been placed in the Council Planning Room for your reference and review.

The parking lots in Coffman Park are required to be worked on after the Irish Festival is complete. Staff will coordinate with the Schools as well so that the students are informed which lot(s) are available for their use. The contract has a completion date of October 27, 2017.

The budgeted funds for the 2017 Parking Lot and Shared-Use Path Maintenance Program in the 2017 - 2021 Capital Improvement Program are \$310,000 from account AT173, Annual Shared Use Path Maintenance and \$415,000 from account AT177, Annual Parking Lot Maintenance, for a total program budget of \$725,000.

Strawser Paving Company submitted the lowest and best bid of \$648,736.88. Staff has thoroughly reviewed all bids and a summary of the bids are listed below.

### Recommendation

Staff has thoroughly reviewed the bid submitted by Strawser Paving Company. Previous experience with Strawser Paving Company has been favorable, including these recent projects: multiple annual Street Maintenance Programs (2013, 2014, 2015 (Part 2), 2016 and 2017) and multiple annual 2016 Parking Lot and Shared-Use Maintenance Programs (2015 and 2016).

Staff recommends Council approval of Resolution No. 45-17, accepting as lowest and best the bid of Strawser Paving Company in the amount of \$648,736.88 and authorizing the City Manager to enter into a contract with Strawser Paving Company for this project.

**Section 1.** The bid submitted by Strawser Paving Company, Inc. in the total amount of \$648,736.88 is hereby accepted.


