Focus & Results

Goal #1: Enhance our readiness and demonstrate our ability to effectively respond to and successfully resolve critical incidents, major crimes, and/or issues of significant community concern.

- Violent crimes were unchanged from 2017 to 2018 with 7 YTD
- 3.5% increase in reported crimes YTD from 2017

Goal #2: Reduce theft offenses throughout the city.

- 33.9% decrease in theft offenses from 2017 YTD
- 32.6% decrease in thefts from vehicles from 2017 YTD
- 12.5% decrease in burglaries and B&Es from 2017 YTD

Goal #3: Improve overall traffic safety in the city.

- 2.3% increase in traffic crashes from 2017 YTD
- 1.8% increase in injury traffic crashes from 2017 YTD
- 6.7% decrease in OVI related traffic crashes from 2017 YTD

Goal #4: Enhance and demonstrate our ability to effectively address drug offenses that contribute to crime affecting the city.

- 167 criminal arrests related to drug activity; 212 drug offense charges YTD







That is why Dublin Police are working to stay ahead of criminals each day and reduce one of the most common crimes in the City – thefts from motor vehicles. The Dublin Police Department would like to remind residents, corporate citizens and visitors to take steps to prevent thefts from vehicles. That includes the following:

1. removing valuables from vehicles
2. locking vehicle doors
3. calling the Dublin Police Department immediately if you witness a crime or something suspicious (call 911 to report a crime in progress)

Whether you are parked in a lot all day for work, heading into the store for a few minutes, or in the comfort of your own neighborhood, don't make it easy for thieves to break in. It takes seconds for a thief to break into your vehicle, grab valuables in sight and get away. Always be sure to hide your valuables or take them with you and lock your vehicle.













ACCIDENT ANALYSIS

April - June 2018

April 1, 2018 through June 30, 2018 there were 234 reported traffic accidents, resulting in an average 2.57 accidents/day. Compared to 2017, accidents decreased 4.88% (2018 = 234; 2017 = 246).

Personal injury accidents (66) accounted for 28.2% of the total. Property damage accidents accounted for the majority of our activity with 168 reports being filed (71.8%).


District 2 experienced the majority of accidents (82 or 35.0%) followed by District 5 with 63 accidents (26.9%). There were 29 collisions in District 1 (12.4%); 19 collisions in District 3 (8.1%); and 41 collisions in District 4 (17.5%). The busiest day of the week for accident activity for the reporting period was Tuesday with 50 accidents (21.4%) reported. The second busiest day was Wednesday with 42 accidents (17.9%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 14 (6.0%); Monday = 35 (15.0%); Thursday = 32 (13.7%); Friday = 33 (14.1%); and Saturday = 28 (12.0%).

The most frequent contributing factor was Following Too Closely, which accounted for 78 or 33.3% of the accidents. The next most recurrent contributing factor was tied between Failure To Control accounting for 45 or 19.2% of the accidents for the reporting period. The busiest time of day for accident activity was between 5PM-6PM with 28 (12.0%) of the accidents.


Nine (9) crashes were identified as having been alcohol related (3.9%). The drivers in these accidents were arrested and charged with OVI. One hundred ninety-seven (197) citations were issued to at fault drivers as a result of their accidents (84.2%).



ACCIDENT ANALYSIS

January - June 2018

January 1, 2018 through June 30, 2018 there were 439 reported traffic accidents, resulting in an average 2.43 accidents/day. Compared to 2017, accidents decreased 3.05% (2018 = 439; 2017 = 426).

Personal injury accidents (117) accounted for 26.7% of the total (2 fatalities). Property damage accidents accounted for the majority of our activity with 322 reports being filed (73.3%).

District 2 experienced the majority of accidents (147 or 33.5%) followed by District 5 with 117 accidents (26.7%). There were 58 collisions in District 1 (13.2%), 39 collisions in District 3 (8.9%) and in District 4, 78 accidents (17.8%). The busiest day of the week for accident activity for the reporting period was Tuesday with 91 accidents (20.7%) reported. The next busiest day was Wednesday with 78 accidents (17.8%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 35 (8.0%); Monday = 53 (12.1%); Thursday = 69 (15.7%); Friday = 71 (16.2%); and Saturday = 42 (9.6%).

The most frequent contributing factor was Following Too Closely, which accounted for 135 or 56.5% of the accidents. The next most recurrent contributing factor was Failure To Control (87 or 24.9%) followed by Failure To Yield accounting for 80 or 22.9% of the accidents for the reporting period. The busiest time of day for accident activity was between 4PM-5PM with 43 (9.8%) accidents.

Fourteen (14) crashes were identified as having been alcohol related (3.2%). The drivers in these accidents were arrested and charged with OVI. Three hundred seventy-four (374) citations were issued to at fault drivers as a result of their accidents (85%).
