TO PROSPECTIVE BIDDERS: The following changes shall be made part of the contract documents for this project:

Request for Information:

- 1.** Question: Project specifications list that the arch and precast wings can only be purchased from Contech, would the City allow the purchase of the arch/wingwall system from another supplier so long they are ODOT approved?

Answer: Proposal Notes, Page 65-2 states "THREE-SIDED PRECAST ARCH The three-sided precast arch shall be a ConSpan Bridge Systems product provided by Contech Engineered Solutions, LLC." The City of Dublin will not allow the purchase from another supplier.

- 2.** For the Proof Survey the plan note on Sheet 3/17 says it should be signed, prepared, and submitted by an Ohio Registered Professional Engineer/Surveyor. Does this require an Engineer or Surveyor, or someone who is both?

Answer: The proof survey shall be prepared, signed, and submitted by either an Ohio Professional Engineer, or an Ohio Professional Surveyor, or a person that has both registrations.

- 3.** There is no mention of maintenance of traffic for this job and no bid items for this. Will the City handle the road closure, or will the contractor be responsible for any signage? Lastly is there any closure duration outside interim completion dates?

Answer: Ashbaugh Road at the project site shall be closed to all public pedestrian and vehicle traffic from the start of construction until May 3, 2019 by the contractor. The contractor is responsible for the safety of the work site. All items of work called out for on the plans for which no specific method of payment is provided shall be performed by the contractor with the cost to be included in the unit price bid for the various related items.
