#### Focus & Results

Goal #1: Enhance our readiness and demonstrate our ability to effectively respond to and successfully resolve critical incidents, major crimes, and/or issues of significant community concern.

➤ Violent crimes decreased 8.3% from 2017 to 2018 with 11 YTD

➤ 6.29% decrease in reported crimes YTD from 2017

## Goal #2: Reduce theft offenses throughout the city.

➤31.7% decrease in theft offenses from 2017 YTD

➤35.7% decrease in thefts from vehicles from 2017 YTD

➤32.0% increase in burglaries and B&Es from 2017 YTD

## Goal #3: Improve overall traffic safety in the city.

➤ 1.7% decrease in traffic crashes from 2017 YTD

➤ 2.0% decrease in injury traffic crashes from 2017 YTD

➤ 9.1% decrease in OVI related traffic crashes from 2017 YTD



## Be Smart. Stay Safe.


Every year more than 1.85 million thefts from vehicles take place nationwide costing \$1.2 billion in stolen personal items and accessories. Whether you are parked in a lot all day for work, heading into the store for a few minutes or in the comfort of your own neighborhood, don't make it easy for thieves to break in. It takes seconds for a thief to break into your vehicle, grab valuables in sight and get away. Always be sure to hide your valuables or take them with you and lock your vehicle.

Dublin is a safe city, and you can help make it even safer and prevent crimes of opportunity- Hide your valuables, lock your vehicle, take it with you. Be smart. Stay safe.

#### **Give Thieves a Hard Time**

Don't make it easy for thieves. Help prevent theft from your car by taking these steps:

- If you have more than one stop in a shopping trip, hide your newly purchased items before you leave the first store.
- On quick shopping trips, only take with you what is needed for that errand.
- Park in well-lit, high-traffic areas and when possible.
- Stash the evidence of valuables, too, including chargers, auxiliary cords and suction-cup mounts for navigation systems.
- Completely close all windows and sunroofs. You don't want to make it easy for thieves to reach in your vehicle. Plus, open windows can disable the pressure sensors in some car alarms.






#### CALLS FOR SERVICE







## ACCIDENT ANALYSIS July - September 2018

July 1, 2018 through September 30, 2018 there were 214 reported traffic accidents, resulting in an average 2.33 accidents/day. Compared to 2017, accidents decreased 10.08% (2018 = 214; 2017 = 386).

Personal injury accidents (77) accounted for 36.0% of the total. Property damage accidents accounted for the majority of our activity with 137 reports being filed (64.0%).


District 5 experienced the majority of accidents (66 or 30.8%) followed by District 2 with 65 accidents (30.4%). There were 31 collisions in District 1 (14.5%); 11 collisions in District 3 (5.1%); and 41 collisions in District 4 (19.2%). The busiest day of the week for accident activity for the reporting period was Thursday with 41 accidents (19.2%) reported. The second busiest day was Wednesday with 39 accidents (18.2%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 15 (7.0%); Monday = 37 (17.3%); Tuesday = 26 (12.1%); Friday = 32 (15.0%); and Saturday = 24 (11.2%).

The most frequent contributing factor was Following Too Closely, which accounted for 46 or 21.5% of the accidents. The next most recurrent contributing factor was tied between Failure To Yield accounting for 32 or 15.0% of the accidents for the reporting period. The busiest time of day for accident activity was between 5PM-6PM with 28 (13.1%) of the accidents.





## ACCIDENT ANALYSIS January - September 2018

January 1, 2018 through September 30, 2018 there were 653 reported traffic accidents, resulting in an average 2.39 accidents/day. Compared to 2017, accidents decreased 1.7% (2018 = 653; 2017 = 664).

Personal injury accidents (194) accounted for 29.7% of the total (2 fatalities). Property damage accidents accounted for the majority of our activity with 459 reports being filed (70.3%).


District 2 experienced the majority of accidents (212 or 32.5%) followed by District 5 with 183 accidents (28.0%). There were 89 collisions in District 1 (13.6%), 212 collisions in District 3 (7.7%) and in District 4, 119 accidents (18.2%). The busiest day of the week for accident activity for the reporting period was tied between Tuesday and Wednesday with 117 accidents each (17.9%) reported. The next busiest day was Thursday with 110 accidents (16.8%) reported. Accident activity for the remaining days of the week were as follows: Sunday = 50 (7.7%); Monday = 90 (13.8%); Friday = 103 (15.8%); and Saturday = 66 (10.1%).

The most frequent contributing factor was Following Too Closely, which accounted for 181 or 27.7% of the accidents. The next most recurrent contributing factor was Failure To Yield (112 or 17.2%). The busiest time of day for accident activity was between 5PM-6PM with 71 (10.9%) accidents.








## ACCIDENTS BY DAY OF WEEK & SHIFT JANUARY 1 - SEPTEMBER 30, 2018
