**CITY OF DUBLIN – REQUEST FOR QUOTE
Dublin Community Pool South – Leisure Pool Resurface & Repairs**

I. Introduction

The City of Dublin is seeking written responses from licensed, qualified contractors to this Request for Quote (RFQ) to provide repairs to the existing leisure pool shell including resurfacing Diamond Brite, tile, caulking and all related finishes at the Dublin Community Pool South, located at 6363 Woerner Temple Road, Dublin, Ohio 43017.

II. Scope of Services

The following outline includes the service parameters that will be necessary to fulfill the terms of any awarded contract:

Community Pool Facility Location:

- 6363 Woerner Temple Road, Dublin, Ohio 43017

Contractor Project Responsibilities/Requirements:

- Contractor will be a licensed applicator of the Diamond Brite product with favorable references
- Project will fall under Prevailing Wage and all rules as required shall be followed:

- Obtain all necessary City of Dublin Building Permits
- Obtain all necessary City of Dublin Inspections
- Maintain a safe and clean worksite at the completion of each day of work, keep restroom facility open during construction
- Conduct all work between hours of 7:00am and 9:00pm. Monday through Friday, in compliance with the City of Dublin's noise ordinance.
- Items not needing repair, should be protected. Any areas outside the scope damaged are the responsibility of the contractor to repair at their cost.

- Provide an on-site supervisor during contracted work
- Have emergency numbers available and on-site numbers containing Fire, Ambulance, Police, Utility Companies, and Company contacts
- Provide the City with a copy of an appropriate Certificate of Insurance for a comprehensive general liability policy (occurrence form) including personal injury liability, broad form property damage, operations liability and contractual liability in an amount not less than One Million Dollars which covers the direct and indirect acts and omissions of the Service Provider, their agents, contractors, employees, members, or guests
- Provide current certificate of Worker's Compensation

PROJECT DESCRIPTION

The City of Dublin is seeking quotes for repair/replacement of the entire Diamond Brite pool surface and ceramic tiles in the leisure pool.

- a. Diamond Brite
 - i. Identify and repair hollow spots in pool floor and walls including repairs to foundational areas that support the Diamond Brite application and any other site preparation required prior to application
- b. Tile
 - i. Remove and replace broken/loose/missing tiles
 - ii. Remove and replace all broken/loose/missing depth marker/no diving tiles on pool deck surrounding lap and leisure pool
- c. Caulking
 - i. Remove and replace caulking between Diamond Brite and stainless-steel gutter, as well as expansion joints
- d. Expansion Joints
 - i. Remove and repair any loose aggregate at the expansion joints

Construction Schedule:

- **Construction may begin immediately, weather dependent, and must be completed prior to May 1st.**

III. RFP Submission Requirements

- a. Description of Company – Provide a brief company overview including history, available equipment, number of employees, affiliated companies, etc.

- b. Experience of Contractor – List relevant company experience within the past three (3) years, including current contracts, and include reference/contact names and numbers. Listing of four projects will be sufficient.
- c. Experience of Key Personnel – Briefly summarize the experience of key personnel who would be working on this contract. Include copies of application licenses for personnel applying the Diamond Brite material.
- d. Project Time line – Brief statement of when project could be started and anticipated number of days for completion.
- e. Price Proposal – Provide a cost proposal for delivering the services described in this RFP. The proposal should be inclusive of all costs for installation and broken down with materials and labor for each task.
- f. Warranties – Provide a minimum of (1) year warranty on all materials and labor plus any manufacturer’s warranties.
- g. Deadline for Submission – All proposals must be received by **5:00 P.M. on Friday, February 8, 2019.**
