Re:	Eggoholic Dublin LLC DBA Egg O Holic Application for D1 Permit

I. <u>INTRODUCTION</u>

The City of Dublin recently received a Notice to Legislative Authority ("Notice") from the Ohio Division of Liquor Control regarding Eggoholic Dublin LLC DBA Egg O Holic ("Eggoholic"). Dublin received this Notice pursuant to R.C. 4303.26 because Eggoholic is applying for a new D1 permit and the proposed location for the permit premises is located within the corporate limits of Dublin. As such, Dublin may request a hearing regarding the advisability of the issuance, transfer of ownership, or transfer of location of the permit.

II. BACKGROUND


Eggoholic is a domestic limited liability company that is actively registered with the Ohio Secretary of State. The address designated for the permit premises is 331 W. Bridge Street, Dublin, Ohio 43017. Eggoholic is seeking to obtain a D1 permit, which allows for the sale of beer only for on premises consumption or in original sealed containers for carry out until 1:00 A.M.

D1 permits may only be issued to the owner or operator of a hotel, of a retail food establishment or a food service operation licensed pursuant to Ohio Revised Code ("ORC") chapter 3717, a club, an amusement park, a drugstore, a lunch stand, a boat, or a vessel. Eggoholic must meet the ORC requirements in order to obtain the D1 permit. The Ohio Division of Liquor Control, and not the City, holds the authority to determine if Eggoholic is the type of business eligible to receive a D1 permit.

III. <u>RECOMMENDATION</u>

It appears unnecessary to request a hearing in this matter as Eggoholic does not have a history of liquor law violations. Regardless of whether Dublin desires to request a hearing, the Notice must be signed and returned to the Ohio Division of Liquor Control no later than April 3, 2020.
