Bridge Park Avenue and Dale Drive Informal Review

Proposal: Development in Block G consisting of a 4-story condominium building, a

6-story parking garage, and a 7-story mixed-use building.

Location: Northeast of the intersection of Bridge Park Avenue and Mooney Street.

Request: Informal review and feedback for a potential development application.

RESULT:

The Commission reviewed and commented on a request for informal feedback for the construction of three new buildings on a ± 2.29 -acre block—a seven story building containing $\pm 144,954$ square feet of office space, $\pm 11,000$ square feet of retail, $\pm 6,100$ square feet of restaurant space at the ground story, a 468-space parking structure, and a multi-family building containing a total of 42 dwelling units with a ± 0.20 -acre private amenity space. The site is on the north side of Bridge Park Avenue between Dale Drive and Mooney Street and south of Tuller Ridge Drive within the Bridge Street Scioto River Neighborhood District.

The Commission requested the applicant make revisions to the garage elevations to create a design aesthetic similar to the existing garage in Bridge Park. The Commission appreciated the warehouse look of the multi-family building and encouraged the applicant to treat the blank interior wall with art or greenery. The Commission also requested that the applicant work toward creating a unique open space for this block and to investigate additional detailing for the office building architecture.
