Q. Item 202 Structure Removed, Misc. - Water Well Removal - Can the well casing size and depth of well be provided?

A. This information was not collected in previous surveys.

Q. Item 207 Erosion & Sediment Control - Temporary Diversion Channel - What is the desired width of the diversion channel bottom?

A. The diversion channel shall have a 2-foot bottom width.

Q. Item 207 Erosion & Sediment Control - Temporary Diversion Channel - Erosion Control Mat Type B - What type of anchors and spacing are needed for this item?

A. Anchors and spacing shall be in conformance with CMS Item 671.

Q. Item SPEC Drain Tile Tie-in - Details states that an endwall shall be installed at the outlet of tile 8" and larger. For bidding purposes should the contractor assume that all five tile tie in locations are 8" or larger tile?

A. Yes
