City of Dublin Traffic Diversion Program

Purpose

The City of Dublin's Adult Traffic Diversion Program is designed to assist with the processing of minor misdemeanor, non-accident violations. This program helps to promote safe driving thru education and to efficiently resolve cases without going to pre-trial or trial. Eligible defendants who successfully complete the program avoid conviction and are able to keep the violation off of their driving record.

Eligibility

In order to qualify for the program, you must meet the following requirements:

- You have been charged with an eligible offense which includes most non accident, minor misdemeanor traffic violations. Speeding in a school zone, construction zone and speeding 30 MPH or more over the limit are not eligible violations.
- You have a satisfactory driving record which means that you have no convictions during the last 4 years for any traffic violation.
- You have not previously participated in the City of Dublin's Adult Traffic Diversion Program.
- You have valid proof of insurance covering the vehicle you were driving at the time of the violation.
- You have the ability to pay for court costs and the driving course.

Successful Completion

If you successfully complete the Adult Traffic Diversion Program, the charge will be dismissed. This includes completing the course, paying all court costs and the course fee, and providing proof of insurance. Nothing will be reported to the BMV and no points will be assessed on your driving record.

Termination

If you fail to complete all of the required conditions by the established deadline, you will be terminated from the program. Once terminated, you will have the option of pleading guilty and paying the waiver or appearing in court to enter a no contest or not guilty plea to the charge.
