



INVITATION FOR BIDS

Project Name: DEER RUN FORCE MAIN AND LIFT STATION

The City of Dublin Ohio will receive electronic bids for the materials and labor necessary for the construction of the Deer Run Force Main and Lift Station project. Bids shall be received by the City of Dublin via the Bid Express ® service at www.bidexpress.com until 11:00 A.M. local time on Tuesday, November 23, 2021. Bid documents will not be available until 8:00 A.M. on Tuesday, November 2, 2021.

The City of Dublin may choose to not award the bid—and bidders shall hold bids open—until sixty days after the bid opening. The work for which bids are invited consists of: 12,742 ft. of 16-inch force main; pre-fabricated 12 ft. x 26 ft. pump station control building; 8 ft. dia. junction chamber; 10 ft. dia. lift station; bioxide tank; asphalt paving; guardrail; and landscaping. The cost estimate for the Project is \$4,000,000.

As a bidder, you must register, set up to bid, and review each solicitation you intend to bid electronically on before bidding. **Note:** Navigation of the Bid Express service is FREE unless you select a solicitation for bidding and complete your purchase.

Each bidder is required to furnish with its proposal a Bid Guaranty in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a surety company or corporation licensed in the State of Ohio to provide said surety.

All contractors and subcontractors involved with the project will to the extent practicable use Ohio products, materials, services and labor in the implementation of their project. Payment of Prevailing Wages is required for this Project.

The City of Dublin reserves the right to accept or reject any or all bids, to waive any informalities or irregularities in the bidding process and to enter into a contract with the bidder whom, in its opinion, offers the lowest and best bid.

Each bidder must ensure that all employees and applicants for employment are not discriminated against based on race, color, religion, sex, or national origin.
