#### HISTORIC DUBLIN SIGN GUIDELINES

Number of Signs:	One primary only
Wall Signs:	No more than 6-square feet in area, including frame
Window Signs:	10% of window area, maximum coverage of 4-square feet
Materials:	Illusion of natural or painted wood, tin, iron are acceptable. Painted window graphics are allowed
Shape:	Cannot be in shape of product or logo. Early American Shapes are preferred.
Color:	Maximum 3 colors; must compliment architectural style of building.
Lettering:	Must use approved sign lettering styles found in guidelines.
Allowable Lighting:	External goosenecks only



#### **DESIGN CONCEPT | PRIMARY SIGN**

Two (2) new matte black traditional gooseneck light fixtures to be installed over proposed sign location with warm light (2700-3000k) LED downlit bulbs.

Proposed sign to be wood backer with a dark ebony stain and wood frame with a lighter salem stain. MISSING JIMMY'S dimensional wood letters, with 1/2" deep returns to be installed on wood backer in Dublin-approved 'American Typewriter Bold' font painted white with exterior grade oil-based enamel traditional sign painter's paint. All hardware to be hidden for clean, professional look.

#### **DESIGN CONCEPT | ADDITIONAL GRAPHICS**

The existing restaurant space is comprised of three ground floor units and subsequently has three exterior doors. Proposed additional wayfinding and privacy graphics include:

12x12 white vinyl door graphic directing patrons to main entry

12x12 white vinyl door graphic identifying the service entrance

Privacy film on window and door glass at service entry






