Re: Resolution 42-22 – A Resolution Declaring Certain City-Owned Property As

Surplus and Authorizing the City Manager to Dispose of Said Property in

Accordance with Section 37.07 of the Dublin Codified Ordinances

#### **Background**

Section 37.07 of the Dublin Codified Ordinance requires City Council authorization for disposal of all assets or other property valued at \$5,000 or above. As Council is aware, a replacement schedule for assets is identified as part of the Capital Improvements Program (CIP). Before an asset is taken out of service, an evaluation is completed as to current condition and maintenance history. If, after the evaluation, the asset is determined to have had minimal maintenance costs and staff believes the asset provides continued value to the City, the asset will be maintained as part of the City's fleet and the replacement schedule will be modified.

Resolution No 42-22 authorizes the City Manager to dispose of certain assets that are no longer in service. The assets which Fleet has identified for replacement are detailed in the attached Exhibit.

This information will be posted on the City of Dublin website, along with a link to take customers directly to the auction website at <a href="www.GovDeals.com">www.GovDeals.com</a>. In certain instances where an asset may have a high trade-in value, the Fleet Manager may obtain a written trade-in quote that will then form the basis of the minimum asking price for the auction. If the auction fails to yield bids that meet the minimum asking price, the asset will be traded for credit toward the replacement asset as stipulated in Article 37.07 of the Dublin Codified Ordinances.

Under the terms of the City's agreement with GovDeals, the City will pay a commission to GovDeals of 7.5% of sale proceeds; however, the City will incur no cost unless the items are sold. The GovDeals site is well-known among public entities and will provide a broad pool of prospective buyers for City surplus items.

#### Recommendation

Staff recommends adoption of Resolution No. 42-22 authorizing the City Manager to dispose of surplus property in a manner consistent with Section 37.07 of the Dublin Codified Ordinances.

# A RESOLUTION DECLARING CERTAIN CITY-OWNED PROPERTY AS SURPLUS AND AUTHORIZING THE CITY MANAGER TO DISPOSE OF SAID PROPERTY IN ACCORDANCE WITH SECTION 37.07 OF THE DUBLIN CODIFIED ORDINANCES

**WHEREAS,** the City of Dublin possesses certain vehicle and equipment assets used in the performance of its daily operations; and

**WHEREAS**, these vehicle and equipment assets have reached the end of their useful life for City purposes; and

**WHEREAS,** it has been determined that the City should maximize the return on investment by selling these assets; and

**WHEREAS,** the City has chosen GovDeals as the vendor to implement an internet auction; and

**WHEREAS,** the City may elect to use the trade-in for credit option for certain assets as stipulated in Article 37.07 of the Dublin Codified Ordinances if the trade-in value exceeds the auction price;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of Dublin, State of Ohio, \_\_\_\_\_ of its elected members concurring, that:

**Section 1.** The City Manager is hereby authorized to dispose of personal property, vehicle and equipment assets that have been declared as surplus through the use of internet auction or for trade in for credit at the time of purchase of the replacement property.

**Section 2.** This auction will be conducted using a third-party contractor, namely:

The contract outlining the specifics of the terms and conditions under which this contractor will carry out this service to the City can be made available upon request to the Department of Finance.

**Section 3**. If the trade in for credit at the time of purchase of replacement property is utilized, the City will establish the trade in value separately from the purchase price of the replacement property and verify that this value represents the fair market value for the traded property as required by Dublin Codified Ordinances Section 37.07(A)(5).

**Section 4.** The Council of the City of Dublin here by declares the property listed in the attached Exhibit as surplus and authorizes the City Manager to dispose of said property in a manner consistent with Section 37.07 of the Dublin Codified Ordinances.

**Section 5.** This Resolution shall take effect and be in force upon passage in accordance with Section 4.04(a) of the Revised Charter.
